ORDER:

In the Government Order first read above, administrative sanction was accorded for construction of 80 Bridge Works out of 136 Bridge works as per the Announcement made by the Hon'ble Minister for Rural Development with the financial assistance from the NABARD under Rural Infrastructure Development Fund (RIDF) - XXVIII for the year 2022-23 at an estimated cost of Rs.27476.73 Lakh.

2. In the Letter second read above, the Commissioner of Rural Development and Panchayat Raj has requested the Government to release the start-up advance of Rs.41.8870 Crore (being 20%) against the NABARD loan component of Rs.209.4352 Crore under NABARD – RIDF XXVIII for the year 2022-23.

3. The Government have carefully examined the above proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to accept the same and release an amount of Rs.41,88,70,000/- (Rupees Forty One Crore Eighty Eight Lakh and Seventy Thousand only) as start-up advance under NABARD-RIDF XXVIII (2022-23) out of the BE of Rs.245.8246 Crore for the year 2023-24 and order accordingly. The Director of Rural Development and Panchayat Raj is directed to take necessary action for reimbursement of this amount from the NABARD to Government.
