ORDER:-

In the Government order first read above, orders were issued for revision of wages from Rs.281/- to Rs.294/- per person per day with effect from 01.04.2023 under MGNREGS and consequently in the Government order second read above, orders were issued revising Rural Schedule of Rates (RSoR) for the Financial year 2023-24 under MGNREGS.

- 2. In the Government order third read above, orders were issued according permission to take up construction of 500 new Anganwadi Centers at a total cost of Rs.70.00 crore and in the Government order fourth read above, orders were issued according permission to take up certain works to the tune of Rs.2,197.42 crore under MGNREGS 2023-2024.
- 3. In the letter fifth read above, the Director of Rural Development and Panchayat Raj, has sent a proposal for the construction of 1,000 Nos. of Dug Wells (750 Nos Individual and 250 Nos. Community) at a cost of Rs.130.78 crore, construction of 200 Nos. of Food Grain Godowns (Model I More than 500 Card Holders) at a cost of Rs.25.34 crore and 200 Nos. of Food Grain Godowns (Model II Less than 500 Card Holders) at a cost of Rs.18.64 crore, construction of 150 Nos. of Milk Producer's Co-operative Societies at a cost of Rs.30.20 crore and construction of 100 Nos. of 1.5m Span Culverts, 100 Nos. of 3.00m Span Culverts and 100 Nos. of Minor Bridges at a total cost of Rs.60.85 crore and requested the Government to sanction a sum of Rs.54.35 crore towards State Share for the above works.
- 4. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in detail and decided to accord permission to take up the following works:
 - a) Construction of 1,000 Nos. of Dug Wells (750 Nos Individual and 250 Nos. Community) in rural areas at a cost of Rs.130.78 crore;
 - b) Construction of 200 Nos. of Food Grain Godowns (Model I More than 500 Card Holders) in rural areas at a cost of Rs.25.34 crore and 200 Nos. of Food Grain Godowns (Model II Less than 500 Card Holders) in rural areas at a cost of Rs.18.64 crore;
 - c) Construction of 150 Nos. of Milk Producer's Co-operative Societies in rural areas at a cost of Rs.30.20 crore;
 - d) Construction of 100 Nos. of 1.5m Span Culverts, 100 Nos. of 3.00m Span Culverts and 100 Nos. of Minor Bridges as standalone works in rural areas at a total cost of Rs.60.85 crore.
- 5. The funding pattern for the sanctioned works in para 4 above shall be as follows:-

The Labour cost is borne 100% by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and

the State Government respectively. The funds requirement and the Central and the State share for each work is as follows:-

6. The General conditions for work selection and Non-Negotiable items for the sanctioned works in para 4 above shall be as follows:-

(i) General Conditions for Work Selection

- All works will be selected as per the GIS plan prepared for each village panchayats.
- 2. Priority will be given to 7,705 Village Panchayats selected for the implementation of Anaithu Grama Anna Marumalarchi Thittam-II and Kalaignarin All Village Integrated Agriculture Development Programme.
- 3. Beneficiary Selection for Dug wells will be done in consultation with Agriculture/ Agriculture Engineering Department.
- 4. The authenticity of Small/Marginal and SC/ST Farmers for providing Dug wells will be duly verified with necessary certificates in consultation with Revenue Department.

5. The site selection for Milk Producer's Co-operative Society should be done in consultation with Aavin and MPCS (Milk Producer's Co-operative Society)

6. The Site selection for Food Grain Godowns should be done in consultation with Registrar of Co-operative Societies and Civil Supplies

Corporation.

Construction of cross drainage structures shall be selected on the following basis (1) roads which are connecting habitations, (ii) Taluk and Panchayat headquarters, (iii) roads linking to marketing centres, educational centres, health centres, etc.

The existing damaged cross drainage structures and cross drainage

structures having insufficient vent way shall also be selected.

Normally, when the ground generally slopes from one side to another, the embankment intercepts natural flow of rainwater. In such cases, balancing culverts are provided at the rate of one per 500m length of road to avoid water logging.

10. Selection of type of cross drainage structure for a particular road primarily depends on the linear waterway and hydraulic particulars apart from topography, catchment area, Cross-section of the stream at proposed crossing, High Flood Level / Maximum Flood Level and Road Top Level, etc.,

11. Span of the culvert, Minor Bridge and causeway shall be fixed based on linear waterway of the channel/stream.

12. Generally, for catchment area of less than 1.25 sq km (125 hectares), a culvert is required and if the catchment area is more than 1.25 sq km, a minor bridge is to be provided.

13. The District Collector should document various process of the Scheme implementation starting from selection of works to completion of works, documenting the works with photographs, video etc.,

(ii) Non-Negotiable Items:

- 1. Citizen Information Board shall be kept at the work site in 3 X 4 feet with all necessary information as per the framework given by the Government of India vide Ref No: k11023/1/1/2017 - MGNREGA (IV), Ministry of Rural Development, Dated 07.04.2017. The Citizen Information Board with wall writing shall be painted at Rs.850/-per unit for Individual Asset and Rs.1,000 for Community Assets. The Citizen Information Board (CIB) should only be wall painted for the works like Panchayat Office Building, Dug wells, Food Grain Godown and Milk Collection Centre.
- 2. Estimate creation, Administrative Sanction and Technical Sanction shall be done in SECURE software except Panchayat Office Building which is a convergence/ devolution work.

- 3. Geo-Tagging of Assets at all three i.e before, during and after completion should be ensured.
- 4. The Government of India have notified the wage rate for the Financial Year 2023-24 as Rs.294/- and the Rural Schedule of Rates has been prepared accordingly for all the estimate preparation. In case of any revision made in Rural Schedule of Rates in future, the same shall be adopted for the works.

In addition to the above said guidelines, the following shall also be adhered during execution of works;

- Resolution should be obtained in the Gram Sabha for all the Selected Works/Beneficiaries Selected and it should be entered work wise in Register No.2 of Mahatma Gandhi NREGA of village panchayats concerned.
- Photographs shall be taken before execution, during execution and after completion of work.
- 7. The Director of Rural Development and Panchayat Raj is requested to give instructions to the District Collectors to implement the sanctioned works with reference to the Guidelines of the scheme and send progress report to Government from time to time. The Financial sanction will be made only after release and realization of Central Share.
- 8. This order issues with concurrence of Finance Department vide U.O No.efile/4434/2023, dated: 11.09.2023.
