In the Meeting held on 16.03.2023, the Central Empowered Committee have approved Labour Budget for State of Tamil Nadu for the year 2023-24 as 20 crore persondays and it was revised as 28 crore persondays in the Empowered Committee meeting held on 23.08.2023.

- 2. In the Government Order 2nd read above, orders were issued according sanction and release of Rs.132,30,00,000/- towards 100% Central Share of Admin component as 1st installment of 1st tranche of funds for the financial year 2023-24.
- 3. In the letter 4th read above, the Government of India under Admin component of MGNREGS, have sanctioned a sum of Rs.132,30,00,000/-(Rupees One Hundred and Thirty Two Crore Thirty Lakh Only) towards 100% of Central Share of Admin component as 2nd installment of 1st Tranche for Salary to regular officers/staff and Non-Salary related Admin Component expenditure under MGNREGS for the financial year 2023-24.
- 4. In pursuance of the above sanction, the Director of Rural Development and Panchayat Raj, has requested the Government to sanction and release a sum of Rs.132,30,00,000/- towards 100% Central Share of Admin component as 2nd installment of 1st tranche of funds for the financial year 2023-24 to meet out the salary to regular officers/staff and Non-Salary related Admin Component expenditure under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) and to permit him to draw disburse the amount to the Admin Account.
- 5. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction and release of Rs.132,30,00,000/- (Rupees One Hundred and Thirty Two Crore Thirty Lakh Only) towards 100% Central Share of Admin component as 2nd installment of 1st tranche of funds for the financial year 2023-24 to meet out the Salary to regular officers/staff and Non-Salary related Admin Component expenditure under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).
