In the letter 2nd read above, the Commissioner of Rural Development and Panchayat Raj has sent a proposal for increasing the consolidated pay for the Computer Assistants working under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) and further to the Government letter 3rd read above, the Director of Rural

Development and Panchayat Raj, has sent a revised proposal in the letter 4th read above, for increasing the consolidated pay for the 1,843 Computer Assistants working under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS).

The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in the letter 4th read above and with modification of the proposal, the Government direct that the consolidated pay of the 1,843 Computer Assistants working under Mahatma Gandhi National Rural Employment Guarantee Scheme be increased from Rs.14,000/- to Rs.16,000/- per month from the date of issue of this order.
- 4. The Director of Rural Development and Panchayat Raj is directed to get the prior concurrence of the Government for the subsequent revision of the consolidated pay of the Computer Assistants.
