ORDER:

In the letter 4th read above the Government of India, Ministry of Rural Development have released a sum of Rs.14,75,25,000/- (Rupees fourteen crore seventy five lakh and twenty five thousand only) as part payment of $\mathbf{1}^{\text{st}}$ installment of Administrative Fund of the Central Assistance for the implementation of the Pradhan Mandri Awaas Yojana (Gramin) for the year 2023-24.

- 2. In pursuance of the above release of part payment, the Director of Rural Development and Panchayat Raj has requested for sanction to accord Government Rs.24,58,75,000/- (Rupees Twenty Four Crore Fifty Eight Lakh and Seventy Five Thousand Only) towards Admin fund for which includes Central and State share and to release the Central Share (60%) of Rs.14,75,25,000/-(Rupees Fourteen Crore Seventy Five Lakh and Twenty Five Thousand Only) and the corresponding State matching Share (40%) of Rs.9,83,50,000/- (Rupees Nine Crore Eighty Three Lakh and Fifty Thousand Only) as part payment of 1st installment of Administrative Fund of the Central Allocation for the year 2023-24.
- 3. The Director of Rural Development and Panchayat Raj has also requested the Government to authorise the Director of Rural Development and Panchayat Raj to draw the funds from the Pay and Accounts (South), Chennai from the head of accounts and disburse the amount to the State Nodal Account of Pradhan Mantri Awaas Yojana (Gramin) and to issue necessary orders early in this regard.
- 4. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj and to accord sanction for release of Rs.24,58,75,000/- (Rupees Twenty four crore fifty eight lakh and seventy five thousand only) towards Admin fund for which includes Central and State share and to release the Central Share (60%) of Rs.14,75,25,000/- (Rupees Fourteen Crore Seventy Five Lakh and Twenty Five Thousand Only) and the corresponding State matching Share (40%) of Rs.9,83,50,000/- (Rupees Nine Crore Eighty Three Lakh and Fifty Thousand Only) as part payment of 1st installment of Administrative Fund of the Central Allocation for the year 2023-24.
