### ORDER:

The Hon'ble Minister (Rural Development) has made the following announcement on the floor of the Legislative Assembly on 30.03.2023:

“ஊரக வளர்ச்சித் துறையின் பணிகளை அனைத்து நிலையிலும் சீரிய முறையில் கண்காணிக்க தொடக்கம் முதல் முடிவு வரை கணினிமயமாக்குதல் (End to End Computerisation) 5 கோடி ரூபாய் மதிப்பீட்டில் துவங்கப்படும்.”

2. Based on the announcement, the Director of Rural Development and Panchayat Raj has sent a proposal for End to End Computerisation in Rural Development and Panchayat Raj Department. In the Government Order first read above, administrative sanction has been issued for End to End Computerisation in Rural Development and Panchayat Raj Department.

3. Now, the Director of Rural Development and Panchayat Raj has sent a proposal stating that a Committee under Section 16(b) of Tamil Nadu Transparency in Tenders Act, 1998 was constituted and the meeting of the Committee was held on 27.09.2023 at 11.00 A.M. in the Directorate of Rural Development and Panchayat Raj. The following Members / Special invitee participated in the meeting:

- (1) Thiru. A.Kuttalingam, Chief Engineer, Directorate of Rural Development & Panchayat Raj.

(2) Dr.S.Valli, Professor and Head, Department of Computer Science Engineering, Anna University.

(3) Tmt.Beula Johnson, Senior Program Manager, TNeGA.

4. The Director of Rural Development and Panchayat Raj has further stated that the Committee discussed and resolved as follows:

*"The National Informatics Centre (NIC), Chennai is maintaining the Online Schemes Monitoring System (OSMS) of Rural development & Panchayat Raj Department schemes since 2010. All the work-related data base is now stored and maintained in the server controlled by NIC, Chennai.*

*The End-to-End Computerisation (E2E) is a work flow process of all stages of work from proposal, estimation, administrative sanction, technical sanction, tendering, measurement of works, payment of bills & asset management. This requires extensive requirement gathering and complete domain knowledge of all the existing schemes of Rural Development and Panchayat Raj Department which is already available with NIC. Therefore the Committee recommends that the National Informatics Centre (NIC) shall be engaged under the section 16(b) of Tamil Nadu Transparency in Tenders Act 1998, for implementation of End-to-End Computerisation in Rural Development and Panchayat Raj Department."*

5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders to engage NIC, Chennai, as per section 16(b) of Tamil Nadu Transparency in Tenders Act, 1998 for the implementation of End to End Computerisation in Rural Development & Panchayat Raj Department based on the recommendation of the Committee.

6. After careful examination, the Government have decided to agree the proposal of the Director of Rural Development and Panchayat Raj and issue orders to engage National Informatics Centre (NIC) Chennai, as per Section 16(b) of Tamil Nadu Transparency in Tenders Act, 1998 for the implementation of End to End Computerisation in Rural Development & Panchayat Raj Department.
