ORDER:

In the Letter first read above, the Commissioner of Rural Development and Panchayat Raj has stated that the proposal for construction of 81 bridges at an estimated cost of Rs.28843.13 Lakh under NABARD-RIDF XXVIII for the year 2022-23 has been submitted to the Government and the same has been forwarded to NABARD on 26.08.2022.

2. He has further stated that the Assistant General Manager, NABARD has informed that out of 81 Bridges proposal, 80 Bridges proposal has been forwarded to NABARD Head office's consideration for loan assistance under RIDF XXVIII and the following 1 Bridge proposal has been dropped and requested to submit an alternative proposal for an amount of Rs.26.64 crore.

3. He has further stated that based on the scrutiny of Bridges proposal received from the Districts (Vellore, Tiruvannamalai and Thanjavur) an alternative Bridges proposal for the construction of 8 Bridges under NABARD-RIDF XXVIII for the year 2022-23 at an estimate cost of Rs.2541.45 Lakh has been prepared.

4. In the meantime, in the letter 2nd read above, the Deputy General Manager, NABARD has stated that the Internal Sanctioning Committee in its 118th meeting held on 02.06.2023 has sanctioned an amount of Rs.2541.45 Lakh as RIDF loan to Rural Development as follows:-

In the letter 3rd read above, the Commissioner of Rural Development and Panchayat Raj has therefore requested the Government to sanction and release a sum Rs.2541.45 Lakh for construction of 8 Bridge works under NABARD – RIDF XXIX for the year 2023-24 since the Escalation cost (5%) has been already provided in the Detailed Project Report.

6. The Government have carefully examined the above proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to accept the same and accord administrative sanction and financial sanction for a sum of Rs.25,41,45,000/- (Rupees Twenty Five Crore Forty One Lakh and Forty Five Thousand only) for construction of 8 Bridge works with loan assistance from the NABARD under RIDF – XXIX for the year 2023-2024 as annexed to this order and order accordingly.
