ORDER:

In the Government Order read above, orders were issued for Re-launching of the Anaithu Grama Anna Marumalarchi Thittam-II (AGAMT-II) for the year 2021-2022 along with the detailed Guidelines.

2. In the Letter read above, the Commissioner of Rural Development and Panchayat Raj has sent the proposal for amending the Guidelines for Re-launching of Anaithu Grama Anna Marumalarchi Thittam-II (AGAMT-II) 2021-2022 under the Para No.7.5(ii) and (iv) - "Tendering", based on the suggestions received from the District Collectors and the suggestions received from the Additional Collectors (Development) / Project Directors and Executive Engineers during the review meeting held on 7th and 8th July 2022.

3. The Commissioner of Rural Development and Panchayat Raj has therefore requested the Government for amending the Guidelines (both in English and Tamil) for Re-launching the Anaithu Grama Anna Marumalarchi Thittam-II (AGAMT-II) for the year 2021-22 issued in G.O. (Ms) No.23, Rural Development and Panchayat Raj (SGS-1) Department, dated 08.03.2022 in the caption of "Tendering" in Para No. 7.5(ii) and (iv).

The Government have carefully examined the proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to amend the Para No.7.5(ii) and (iv) of the Guidelines annexed to the G.O. (Ms) No.23, Rural Development and Panchayat Raj (SGS-1) Department, dated 08.03.2022. Accordingly, the following amendment is issued in English and Tamil:-
