### ORDER:

In the Government Order read above, orders were issued according Administrative Sanction along with detailed Guidelines for the implementation of Namakku Naame Thittam (NNT) for the year 2022-2023 and the Commissioner of Rural Development and Panchayat Raj was permitted to avail the balance amount of Rs.41.66 crore as available in his bank account for implementation of the Namakku Naame Thittam for the year 2022-2023. He was also directed to send the necessary proposal to Government for release of Rs.8.34 crore and Rs.50 crore totally Rs.58.34 crore after utilizing the available bank balance for the said scheme.

2. In the letter read above, the Commissioner of Rural Development and Panchayat Raj has sent a proposal to Government stating that the amount mentioned in the above Government Order for a sum of Rs.41.66 crore is the committed liability amount of Districts under Namakku Naame Thittam (NNT) Scheme (Directorate) 2021-2022. Hence, the Commissioner of Rural Development and Panchayat Raj has requested the Government to issue orders for sanction and release of Rs.50.00 Crore as first installment under Namakku Naame Thittam (NNT) for the year 2022-23 since the NNT scheme is one of the Flagship scheme of the Government.

3. The Government have carefully examined the proposal of the Commissioner of Rural Development and Panchayat Raj for implementation of the Namakku Naame Thittam (NNT) for the year 2022-2023 in detail and decided to sanction and release a sum of Rs.58,34,00,000 (Rupees Fifty Eight Crore and Thirty Four Lakh only) as second and final installment for the implementation of Namakku Naame Thittam (NNT) for the year 2022-2023 (i.e.) after adjusting the amount for a sum of Rs.41.66 Crore.

4. The amount sanctioned in para 3 above, shall be debited to the following Head of account:-

The Commissioner of Rural Development and Panchayat Raj is authorized to draw the amount sanctioned in para 3 above and disburse the same to the Districts (except Chennai) and he is directed to furnish the list of Administrative sanction accorded works and also to send the progress report on the implementation of the Namakku Naame Thittam (NNT) for the year 2022-2023, to the Government.
