ORDER:

In the letter 1st read above, the Ministry of Rural Development has given clearance for upgradation of 275 roads for a length of 1,253.52 Km at a total cost of Rs.745,22,00,000/- out of which Central share is Rs.447.13,00,000/- and State share is Rs.298,09,00,000/- and in the Government Order 2nd read above, Government have accorded Administrative sanction for upgradation of 275 roads for a length of 1,253.52 Km at a total cost of Rs.820,57,00,000/- out of which Central share is Rs.447,13,00,000/- and State share is Rs.373,44,00,000/-

(Includes Additional State Share due to adoption of SoR 2021-22 & Rs.75.35 crore).

- 2. In the letter 4th read above, the Ministry of Rural Development has released central share Rs.90,41,87,500/- and State Share of Rs.60,28,00,000/- and in the Government order 5th read above Government have accorded Administrative sanction for upgradation of 275 roads for a length of 1,253.52 Km at a total cost of Rs.820,57,00,000/- out of which Central share is Rs.447,13,00,000/- and State share Rs.373,44,00,000/- (Includes Additional State Share due to adoption of SoR 2021-22 of Rs.75,35,00,000 /-).
- 3. In the letter 6th read above, the Ministry of Rural Development, Government of India has released Central Share of Rs.90,41,87,500/-(Rupees Ninety crore forty one lakh eighty seven thousand five hundred only) as against State Share of Rs.60,28,00,000/- (Rupees Sixty crore and twenty eight lakh only) towards 1st tranche of 2nd installment under PMGSY III Batch I (2021-2022) for the year 2023-2024.
- 4. In the letter 7th read above, the Director of Rural Development and Panchayat Raj has requested the Government to release Central Share of Rs.90,41,87,500/- (Rupees Ninety crore forty one lakh eighty seven thousand five hundred only) as against State Share of Rs.60,28,00,000/- (Rupees Sixty crore and twenty eight lakh only) towards 1st tranche of 2nd installment of Programme fund under PMGSY III Batch I (2021-2022) for the year 2023-2024.
- 5. In the Government Order 3rd read above while sanctioning funds, a sum of Rs.2,00,000/- (Two lakh only) has been sanctioned excessively in the State share. Accordingly by adjusting the same the Government, after careful examination, accepts the proposal of the Director of Rural Development and Panchayat Raj as mentioned at para 4 above and release a sum of Rs.150.67,87,500/- (Union share of Rs.90.41,87,500/- and State Share of Rs.60.26,00,000/-) towards 1st Tranche of 2nd instalment of Programme Funds under PMGSY III Batch I 2021-2022 for the year 2023-2024.
- 6. The expenditure sanctioned in para 5 above shall be debited under the following head of account.
