



## **ABSTRACT**

Schemes – Koodankulam Nuclear Power Project (KKNPP) – Neighbourhood Development Programme in Tirunelveli District - Administrative sanction given for 10,000 houses for the year 2013-14, 2015-16 and 2016-17 - Extension of 29 posts for the period of 6 more months with effect from 25.03.2018 – Sanction – Orders - Issued.

## **ORDER:**

In the letter fifth read above, the Director of Rural Development and Panchayat Raj has stated that the Hon'ble Chief Minister had announced that a housing scheme will be implemented at the cost of Rs.300 crore and 10,000 concrete houses will be constructed for the poor people living in Koodankulam and neighbouring villages in Tirunelveli District for the year 2013-14 to 2015-16. The scheme is funded by the Department of Atomic Energy, Government of India and funds are released through Nuclear Power Corporation of India Limited (NPCIL) from time to time.

2. The Director of Rural Development and Panchayat Raj has also stated that as per Government Order first read above, 10,000 houses were sanctioned for the people who are living adjacent to KKNPP in 13 Village Panchayats to be constructed

in a phased manner i.e. 5000 houses in the year 2013-14, 3,000 houses in the year 2014-15 and 2,000 houses in the year 2015-16. In the first phase during the year 2013-14, 5,000 beneficiaries were selected and necessary Administrative sanction was accorded for construction of 1,615 houses in 3 village panchayats of Valliyoor block and 3,385 houses in 10 village panchayats of Radhapuram block.

3. As per the Government Order second read above, orders were issued for appointment of 29 retired staff in addition on consolidated basis for construction of 10,000 houses for Koodankulam Nuclear Project(KKNPP)–Neighbourhood Development Programme(NDP) for a period of three years from the date of issue of orders i.e.25.03.2015, which ends on 24.03.2018. Director of Rural Development and Panchayat Raj in his Letters Roc. No.32690/2013/RHS1.2, dated 31.12.2015 and 24.02.2016, submitted a proposal to Government to extend this housing scheme to additional 32 villages in two blocks (Radhapuram & Valliyoor) surrounding the KKNPP area as requested by the Tirunelveli District Collector and recommended by the Apex Committee. Accordingly orders were issued sanctioning remaining 5000 houses to the 32 villages vide Government Order third read above for the year 2015-16 & 2016-17.

4. The Director of Rural Development and Panchayat Raj has further stated that Tirunelveli District Collector has reported in his letter fourth read above, that Administrative Sanction has been accorded for the Construction of 10,000 houses at a total cost of Rs.300 crore and the various stages of progress of construction of houses as detailed below:

**Phase - I**

As elucidated in the tables above, there are 4797 houses are yet to be completed. Considering the various stage of construction, the tenure of 29 retired staff appointed on consolidated basis to execute the above work for a period of three years (upto 24.03.2018), sanctioned vide Government Order second read above may be further extended for a period of 6 months. The break up of various posts sanctioned for the project, at present is as follows:

The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue necessary orders to extend the period of 29 retired staff sanctioned on consolidated basis vide Government Order second read above for a period of 6 months with effect from 25.03.2018 to 24.09.2018 for completion of houses taken up under Koodankulam Neighbourhood Development Programme.

6. The Government after careful examination of the proposal of Director of Rural Development and Panchayat Raj has decided to accept it and extend the period of 29 retired staff sanctioned on consolidated basis vide Government Order second read above for a period of 6 more months with effect from 25.03.2018 for completion of houses taken under Koodankulam Neighbourhood Development Programme with subject to the following conditions:

- i. No additional financial commitment from the State Exchequer (The expenditure should be met out from the interest amount of the Scheme fund).
- ii. No further extension will be given to 29 additional retired staff.
