- 1. Announcement made by Hon'ble Minister for Food and Civil Supplies on the floor of the Tamil Nadu Legislative Assembly during the Budget Session 2023-2024.

ORDER:

The Hon'ble Minister (Food and Civil Supplies) has made a following Announcement on the floor of the Legislative Assembly during the Budget Session 2023-2024:-

"100 Nos of Direct Purchase Centres (DPCs) will be constructed at an estimated cost of Rs.33.00 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS)".

- 2. In the letter Second read above, considering the peak procurement and monsoon period, the Managing Director, Tamil Nadu Civil Supplies Corporation, has requested the Government to increase the storage capacity of Direct Purchase Centre (DPC) from 100 MT to 250 MT at the unit cost of Rs.62.50 lakh and furthermore the Co-operation, Food and Consumer Protection Department has requested Rural Development and Panchayat Raj Department to accord necessary Administrative and Financial Sanction in this regard.
- 3. In pursuance of the above Announcement, in the letter 3nd read above, the Director of Rural Development and Panchayat Raj, has sent a proposal for construction of 100 Food Grain Godowns-Type-3 (Direct Purchase Centre) with a storage capacity each of 250 MT at the unit cost of Rs.60.00 lakh to a total estimated cost of Rs.60.00 crore under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) 2023-2024.
- 4. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in detail and decided to accept the same with a slight modification. Accordingly, the Government issue the following orders:-
 - (i) Administrative sanction is accorded for construction of 55 Food Grain Godowns-Type-3 (Direct Purchase Centre) with a storage capacity each of 250 MT at the unit cost of Rs.60.00 lakh to a total estimated cost of Rs.33.00 crore under Mahatma Gandhi NREGS 2023-2024;
 - (ii) Of the total estimated cost of Rs.33.00 crore under MGNREGS, sanction is accorded to a sum of Rs.7.83 crore towards 25% of State share of material component for the construction of above 55 Food Grain Godowns-Type-3 (Direct Purchase Centre) under Mahatma Gandhi NREGS 2023-2024;
 - (iii) Concurrence on the list of proposed locations where the 55 Food Grain Godowns-Type-3 (Direct Purchase Centre) under Mahatma Gandhi NREGS 2023-2024, are proposed to be constructed, should be obtained from the Finance (CF&CP) Department before the commencement of the works.
- 5. The funding pattern for the sanctioned works in para 4 above shall be as follows:-

The labour cost is borne 100% by the Government of India and the material cost is shared at the ratio of 75:25 by the Government of India and

the State Government respectively. The fund requirement and the Central and the State shares are as follows:

6. The details of Work Selection and Non-Negotiable items to be followed during the execution of work shall be as follows:-

(i) Work Selection

1. All works will be selected as per the GIS plan prepared for each village panchayat.

- 2. The Site selection for the Food Grain Godown-Type-3 (Direct Purchase Centre) should be done by Tamil Nadu Civil Supplies Corporation and with the concurrence of the Finance Department and inform the list of places to the Rural Development and Panchayat Raj Department.
- 3. The District Collector should document various process of the Scheme's implementation, starting from the selection of works to their completion, documenting the works with photographs, video etc.,

(ii) Non-Negotiable Items:

- 1. Citizen Information Board shall be kept at the work site in 3 X 4 feet with all necessary information as per the framework given by the Government of India vide Ref No: k11023/1/1/2017, MGNREGA (IV), Ministry of Rural Development, dated 07.04.2017. The Citizen Information Board with wall writing shall be painted at Rs.850/-per unit for Individual Assets and Rs.1,000 for Community Assets. The Citizen Information Board (CIB) should only be wall painted for the Food Grain Godown-Type-3 (Direct Purchase Centre) work.
- 2. Estimate creation, Administrative Sanction and Technical Sanction shall be done in SECURE software.
- 3. Geo-Tagging of Assets at all three stages i.e before, during and after completion should be ensured.
- 4. The Government of India have notified the wage rate for the Financial Year 2023-24 as Rs.294/- per day in respect of Tamil Nadu. Accordingly, notified wage rate for 2023-24 and Rural Schedule of Rates 2023-24 have been approved by the Government. In case of any revision is made to the Rural Schedule of Rates in the future, the same shall be adopted for the works.

In addition to the above mentioned guidelines, the following shall also be adhered to during the execution of works;

- A resolution should be obtained for in the Gram Sabha for all the selected Works and it should be entered work-wise in Register No.2 of the Mahatma Gandhi NREGA of the village panchayats concerned.
- Photographs shall be taken before execution, during execution and after completion of work.

- 7. The Director of Rural Development and Panchayat Raj is requested to send the progress report periodically to Government. Financial releases for the above sanctioned works shall be made only after realization of Government of India share.
- 8. This order issues with the concurrence of Finance Department vide U.O.No.e6807/RD/2023, dated:27.02.2024.
