Rural Development and Panchayat Raj Department – Dharmapuri District payment of compensation to the Forest Department for laying approach road from Vachathi to Kalasapadi via Arasanatham and Poigundanvalasu at Sitheri Panchayat and formation of road from Thimmalammedu to Kotturmalai Village and upgradation of L.Malaiyur foot hill to L.Malaiyur road in Dindigul District - Rs.5,75,54,027/- met from Scheme Component of Pooled Assigned Revenue (SCPAR) - Orders- Issued.

#### **ORDER:-**

In the Government order first read above, orders have been issued to release of first installment of Pooled Assigned Revenue to Rural Local Bodies for the year 2022-2023 with guidelines.

2. The Director of Rural Development and Panchayat Raj, in his letter 2<sup>nd</sup> read above, has stated that the Forest Department has accorded approval to lay road from Vachathi to Kalasapadi Tribal Village via Arasanatham, Poigundavalasu at Sitheri Panchayat, Pappireddipatti Panchayat Union and from Thimmalanmedu to Kottur at Vattuvanahalli Panchayat, Pennagaram Panchayat Union, Dharmapuri District. Further the Director of Rural Development and Panchayat Raj has stated that the Dharmapuri District Forest Officer has informed that the District Collector, Dharmapuri has sent proposal to provide Government fund to issue compensation for the forest lands provided by the forest Department to the said roads under Forest area. The details of compensation amount is as follows:-

The Director of Rural Development and Panchayat Raj has forwarded the proposal of the Dharmapuri District Collector to provide compensation amount of Rs.4,03,45,629/- to sanction Forest Department.

3. In reference 3<sup>rd</sup> read above the Director of Rural Development and Panchayat Raj has again sent one more proposal and requested additional Rs.1,72,08,398/- for upgradation of L.Malaiyur foot hill to L.Malaiyur road at Lingavadi panchayat in Natham Panchayat Union in Dindigul District. Totally, the Director of Rural Development and Panchayat Raj has requested **Rs.5,75,54,027/-** to sanction Forest Department for lay road. The details of compensation amount is as follows:-

Totally, the Director of Rural Development and Panchayat Raj has requested Rs.5,75,54,027/- to sanction Forest Department for lay road.

4. The Director of Rural Development and Panchayat Raj has also requested for the following:-

- i. To sanction the fund Rs.5,75,54,027/- for obtaining stage II forest clearance for laying the 3 roads (two roads in Dharmapuri District and one in Dindigul District) in Forest Area.
- ii. To create a separate Head of account for providing Budgetary provision for making payment towards obtaining Forest Clearance.
- iii. To authorize Director of Rural Development and Panchayat Raj to draw and disburse the amount to the concerned District Collectors towards the compensatory levies.
- 5. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj and decided to relax the provision mentioned in item No.8 of Annexure-II in G.O.(Ms) No.5, Rural Development and Panchayat Raj (PR.1) Department, dated 2.2.2023 and to sanction the fund Rs.5,75,54,027/- (Rupees Five crore seventy five lakh fifty four thousand twenty seven only) under Scheme Component of Pooled Assigned Revenue (SCPAR) fund for obtaining stage-II Forest clearance for laying the 3 roads (two roads in Dharmapuri District and one in Dindigul District) in Forest Area.
- 6. This orders issued with the concurrence of Finance Department vide its U.O. No.efile/2557/Infra.4/2023, dated 02.03.2024.
