ORDER:

In the letter second read above, the Director, Social Audit Society of Tamil Nadu (SASTA), has sent a proposal to Government requesting to issue orders for nominating Social Audit Society of Tamil Nadu (SASTA) as Nodal Agency for conducting Social Audit of 15th Central Finance Commission Grants and Modalities for advance payment of cost of facilitation and conduct of Social Audit to pool the funds from the concerned Panchayat Raj Institutions being Social Audited and to transfer it into the bank account of Social Audit Society of Tamil Nadu (SASTA).

2. The Government have carefully examined the proposal of the Director, Social Audit Society of Tamil Nadu (SASTA) in detail and decided to accept the same. Accordingly, the Government issue the following orders:-

- (i) The Social Audit Society of Tamil Nadu (SASTA) be nominated as a Nodal Agency for facilitation and conduct of Social Audit for 15th Central Finance Commission (CFC) Grants in all three tiers of Panchayat Raj Institutions (PRIs);
- (ii) A sum of Rs.6.89 crore per year be sanctioned towards the expenditure for facilitation and conduct of Social Audit under 15th Central Finance Commission (CFC) Grants in all three tiers of the Rural Local Bodies (RLBs);

(P.T.O)

- (iii) The above expenditure towards Social Audit be met by the concerned Panchayat Raj Institutions being Social Audited from the 40 percent of untied grant to be disbursed to the Rural Local Bodies(RLBs);
- (iv) The Director of Rural Development and Panchayat Raj is requested to pool the funds meant for Social Audit under 15th Central Finance Commission(CFC) Grants from the three tiers of Panchayat Raj Institutions(PRIs) which are to be Social Audited and transfer the pooled amount to the account of the Social Audit Society of Tamil Nadu (SASTA) before the commencement of Social Audit every year.

3. The Director, Social Audit Society of Tamil Nadu (SASTA) is requested to send a report on the status of Social Auditing under 15th Central Finance Commission(CFC) Grants to Government periodically.

4. This Order issues with the concurrence of the Finance Department vide U.O. No.e5757/Finance(RD)/2023, dated 07.03.2024.
