## ORDER:

In the Government Order 1<sup>st</sup> read above, orders have been issued according administrative sanction for a sum of Rs.800 Crore as per the Announcement under Rule 110 made by the Hon'ble Chief Minister of Tamil Nadu on the Floor of the Tamil Nadu Legislative Assembly on 19.10.2022 for construction of new Classrooms and additional Classroom Buildings in Panchayat Union Primary and Middle Schools and financial sanction was accorded for a sum of Rs.240 crore.

- 2. In the Government Order 2<sup>nd</sup> read above, orders have been issued by amending the para 5 of the Government Order 1<sup>st</sup> read above,
- 3. In the letter 3<sup>rd</sup> read above, the Commissioner of Rural Development and Panchayat Raj has sent a proposal stating that all the works have been commenced and are in progress at full force towards the implementation of this scheme before the forthcoming academic year.
- 4. Hence, the Commissioner of Rural Development and Panchayat Raj has requested the Government to sanction and release the balance amount of Rs.560 crore out of Rs.800 crore for construction of new Classrooms and additional Classroom Buildings in Panchayat Union Primary and Middle Schools for the year 2022-23.

- 5. The Government have carefully examined the proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to sanction and release the balance amount of Rs.560,00,00,000/- (Rupees Five hundred and sixty crore only) out of 800 crore for construction of new Classrooms and additional Classroom Buildings in Panchayat Union Primary and Middle Schools for the year 2022-23.
- 6. The amount sanctioned in para 5 above, shall be debited to the following new Head of Account:-

- 7. The amount sanctioned in para 5 above shall not be paid in cash, but, shall be credited in the following Public Deposit Account.

- 8. The Commissioner of Rural Development and Panchayat Raj is authorized to draw the amount sanctioned in para 5 above and disburse the same to the Districts (except Chennai) and send the progress report for the construction of new Classrooms and additional Classroom Buildings in Panchayat Union Primary and Middle Schools to the Government.
