## <u>ORDER</u>

In the Government Order 6<sup>th</sup> read above, it has been mentioned that in Government Order 3<sup>rd</sup> read above, the State Government sanctioned excessively a sum of Rs.2,00,000/-(Two Lakh only) in the State Share (i.e) Rs.60,30,00,000/- sanctioned instead of

Rs.60,28,00,000/-. Accordingly by adjusting the same, the Government have released a sum of Rs.150,67,87,500/- (Rs.90,41,87,500/- as Central Share and Rs.60,26,00,000/- as State Share (instead of Rs.60,28,00,000)) towards 1st Tranche of 2nd installment of Programme Funds to State Government of Tamil Nadu under PMGSY-III, Batch-I 2021-2022 for the year 2023-2024.

- 2. In the letter 8th read above, the Director of Rural Development and Panchayat Raj has stated that when the fund proposal has been submitted for 2<sup>nd</sup> Tranche of 2<sup>nd</sup> instalment of programme fund for the financial year 2023-2024 to Ministry of Rural Development, Government of India and the Ministry of Rural Development in their letter 7th read above has examined the fund proposal and stated that as per the previous fund release for 2023-2024 the State has only Rs.180,86,00,000/- as State share instead of Rs.180,88,00,000/- and it indicate there was a shortfall of Rs.2,00,000/- in State release instructed the State to release balance amount of Rs.2,00,000/- so as to enable Government of India to sanction further release of funds.
- 3. The Director of Rural Development and Panchayat Raj has further stated as per Guidelines of Ministry of Rural Development for more than 5.5m carriageways width the Higher Specification Cost is to be admitted in State Share. So, Higher Specification cost of Rs.18.10 Lakh is purely borne by the State Government.
- 4. Accordingly, in the letter 1<sup>st</sup> read above, the Ministry of Rural Development accords clearance for the proposal under PMGSY –III Batch I(2020-2021), and sanctioned Rs.1265.14 crore as total share amount. Out of this Rs.758.98 crore as Central share and Rs.506.16 crore (40% share is Rs.505.98 crore + Higher Specification cost is Rs.0.18 Lakh ) as State share which includes Rs.0.18 lakh as Higher Specification Cost has furnished in Online Management and Monitoring and Accounting System (OMMAS) software. Accordingly, the fund has been released for the total VoP in Phase of PMGSY III Batch -I(2020-21) in respect of Central share.
- 5. Therefore, the Director of Rural Development and Panchayat Raj has requested the Government to release the Shortfall of Rs.2,00,000/- (Rupees Two Lakh only) as State share towards  $2^{nd}$  Tranche of  $2^{nd}$  instalment for the financial year 2023-2024 for the release of further funds from the Ministry of Rural Development, Government of India.
- 6. The Government, after careful examination, accepts the proposal of the Director of Rural Development and Panchayat Raj as mentioned at para 5 above and release the shortfall of Rs.2,00,000/-(Rupees Two Lakh only) as State share towards 2<sup>nd</sup> Tranche of 2<sup>nd</sup> instalment for the financial year 2023-2024.

7. The expenditure sanctioned in para 6 above shall be debited under the following head of account.
