ORDER:

In the Government Order read above, orders were issued according Administrative Sanction for a sum of Rs.1455 crore including Rs.259 crore from the State Funds for implementation of the Anaithu Grama Anna Marumalarchi Thittam-II (AGAMT-II) for the year 2023-2024 along with the detailed Guidelines.

2. In the Letters read above, the Director of Rural Development and Panchayat Raj has stated that as per the orders issued in the reference first cited, out of the allocation of Scheme Component of Pooled Assigned Revenue (SCPAR) an amount of Rs.300 Crore is earmarked to AGAMT-II and Rs.500 Crore is earmarked to Muthalvarin Grama Salaigal Membattu Thittam (MGSMT). Thus, totally Rs.800 Crore is earmarked from SCPAR. That was after allocating an amount of Rs.500 Crore for MGSMT, the balance fund available under SCPAR is Rs.187.44 Crore only (Rs.687.44 Crore – Rs.500 Crore). Hence, there is a shortfall of Rs.112.56 Crore for AGAMT-II. Considering the above, it is planned to revise the allocation of funds for AGAMT-II by dovetailing funds from CFC/SFC to the tune of Rs.150 Crore. It is planned that Rs.75 Crore will be dovetailed from SFC and the balance Rs.75 Crore will be dovetailed from the savings fund available under 14th CFC. Since, the Village Panchayat works for the year 2023-2024 is to be carried out only in AGAMT-II Villages, the amount of Rs.150 Crore may be additionally allocated from CFC/SFC Devolution component and thus the total amount of Rs.338.69 Crore may be allocated from CFC/SFC Devolution component for the year 2023-2024.

3. Considering the above, the Director of Rural Development and Panchayat Raj has requested the Government to issue amendment in G.O.(Ms) No.81, Rural Development and Panchayat Raj (SGS-1) Department, dated 13.06.2023, reallocating the funds for implementation of AGAMT-II for the year 2023-2024.

4. Accordingly, the Government after careful consideration accepts the proposal of Director of Rural Development and Panchayat Raj and issue the following amendment to the funding pattern at para 4 in G.O.(Ms) No.81, Rural Development and Panchayat Raj (SGS-1) Department, dated 13.06.2023.
