### ORDER:

In the Government Order first read above, orders were issued according financial sanction for repair / reconstruction of 14,880 Houses in 149 old Samathuvapurams in Phase-I during the year 2021-2022 as per the Announcement made by the Hon'ble Chief Minister of Tamil Nadu and Hon'ble Minister for Rural Development on the Floor of Tamil Nadu Legislative Assembly on 24.06.2021 and 24.08.2021 along with the detailed Guidelines.

2. The Commissioner of Rural Development and Panchayat Raj in his letter second read above, has sent a proposal to Government to utilize an amount of Rs.39.47 Lakh from the available savings amount in Cuddalore, Coimbatore and Thanjavur Districts as detailed below:-

\* The shortage of Rs.12.32 Lakh for Thanjavur District has been proposed to meet out from the net savings of Rs.22.07 Lakh available in Coimbatore District.

3. The Government have carefully examined the above proposal of the Commissioner of Rural Development and Panchayat Raj in detail and decided to accept the same and accord permission to meet out the required additional fund of Rs.39.47 Lakh (ie., Rs.12.72 Lakh for Cuddalore District, Rs.12.43 Lakh for Coimbatore District and Rs.14.32 Lakh for Thanjavur District) from the saving amount of the Districts as per table at para 2 above for reconstruction of Houses under renovation of Samathuvapurams Phase-I and 6 houses in Cuddalore District, 3 houses in Coimbatore District and 7 houses in Thanjavur District shall be modified.
