ORDER:-

In the meeting held on 27.03.2024, the Central Empowered Committee have approved Labour Budget for State of Tamil Nadu for the year 2024-25 as 20 crore person days. Moreover, the Government of India have approved the wage rate as Rs.319/- per person per day under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for the year 2024-2025.

2. In the letter 2nd read above, Government of India have sanctioned a sum of Rs.921,78,22,000/- (Rupees Nine Hundred and Twenty One Crore

Seventy Eight Lakh and Twenty Two Thousand Only) towards Material Component only (including pending Material liability of previous Financial Year 2023-2024) for implementation of Mahatma Gandhi NREGA as $1^{\rm st}$ installment of $1^{\rm st}$ Tranche of Central Assistance for the Financial Year 2024-2025.

- 3. In the letter 3rd read above, the Director of Rural Development and Panchayat Raj has stated that taking into account the Government of India material component of of 75% share release Rs.921,78,22,000/- (Rupees Nine Hundred and Twenty One Crore Seventy Eight Lakh and Twenty Two Thousand Only), the State Government have to bear the balance 25% of the cost of the material component which amounts to Rs.307,26,07,333/- (Rupees Three Hundred and Seven Crore Twenty Six Lakh Seven Thousand Three Hundred and Thirty Three Only). Therefore, the Director of Rural Development and Panchayat Raj, has requested the Government to sanction a sum of Rs.921,78,22,000/- (Rupees Nine Hundred and Twenty One Crore Seventy Eight Lakh and Twenty Two Thousand Only) towards 75% share of Material component as 1st installment of 1st tranche of Central Assistance for the financial year 2024-25 along with 25% share of the proportionate State Share amount of Rs.307,26,07,333/- (Rupees Three Hundred and Seven Crore Twenty Six Lakh Seven Thousand Three Hundred and Thirty Three Only) totalling to Rs.1229,04,29,333/- (Rupees One Thousand Two Hundred and Twenty Nine Crore Four Lakh Twenty Nine Thousand Three Hundred and Thirty Three Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2024-25 and to permit him to draw and disburse the amount to the Material Component of the State Employment Guarantee Fund (SNA) of Tamil Nadu.
- 4. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, accord sanction and release of Rs.921,78,22,000/- (Rupees Nine Hundred and Twenty One Crore Seventy Eight Lakh and Twenty Two Thousand Only) towards 75% share of Material component as 1st installment of 1st tranche of Central Assistance for the financial year 2024-25 along with 25% share of the proportionate State Share amount of Rs.307,26,07,333/- (Rupees Three Hundred and Seven Crore Twenty Six Lakh Seven Thousand Three Hundred and Thirty Three Only) totaling to Rs.1,229,04,29,333/- (Rupees One Thousand Two Hundred and Twenty Nine Crore Four Lakh Twenty Nine Thousand Three Hundred and Thirty Three Only) under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for the year 2024-25.
