### **ORDER:**

In the Government order first read above, orders have been issued that the posts of Field Surveyor, Draftsman and Deputy Inspector of Survey shall be brought within the preview of the Tamil Nadu Public Service Commission for direct recruitment.

2. The Government after careful examination, decided to accept the suggestion of Director of Survey and Settlement and to issue suitable amendments to the Special Rules for the Tamil Nadu Survey and Land Records Sub-ordinate Service.

3. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

### **NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Survey and Land Records Sub-ordinate Service (Section 31 in Volume-III of the Tamil Nadu Service Manual, 2016)

### **AMENDMENTS**

In the said Special Rules, in rule 6;-

(1) in sub-rule (b), after the expression "by direct recruitment", the expression "except the posts referred to in Serial Nos.1, 10 and 12 namely, Deputy Inspector of Survey and Land Records, Field Surveyor and Draftsman" shall be inserted,

(2) after sub-rule (d), the following sub-rule shall be inserted, namely:-

"(e) No person shall be eligible for appointment by direct recruitment to the posts specified in column (1) of the Table below, unless he possesses the qualifications specified in the corresponding entries in column (2) thereof:-
