## APPENDIX NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Survey and Land Records Subordinate Service.

2. The amendment hereby made shall be deemed to have come into force on the 3rd October 2005.

### AMENDMENT

In the said Special Rules, in rule 2, in the tabular column, under the subheading class II in column (1), for the entries in column (2) against the entries "Category 7 Draftsman" in column(1), the following entries shall be substituted; namely:-

- "1. By promotion from Typographer Grade-II; or
- 2. By transfer from category 4 in class I or
  - 3. If no qualified and suitable candidate is available for such promotion and transfer, direct recruitment:

Provided that every Field Surveyor (Category in Class I) or Typographer, Grade II (Category 8 in Class II) shall at the time of preparation of list of persons eligible for appointment as Draftsman, exercise an option as to the line in which he desires to continue and that the option once exercised shall be final".
