### ORDER:

The Hon'ble Minister for Revenue and Disaster Management, among others, has made the following announcement (Sl.No.17) on the floor of Tamil Nadu Legislative Assembly during the Revenue demand on 17.07.2019 :-

“அனைத்து கிராம வரைபடங்களும் (16721 எண்ணிக்கை) ஸ்கேன் செய்யப்பட்டுள்ளது. எனவே, (A1 தாள் ஒன்றுக்கு) ரூ.200/- என்ற குறைந்த கட்டணத்தில் ஸ்கேன் செய்யப்பட்ட கிராம வரைபடங்களை பொதுமக்கள் இ-சேவை மூலம் பெற்றுக்கொள்ளலாம்”.

2) In the reference second read above, the Director of Survey and Settlement has stated that under the erstwhile Centrally Sponsored Scheme, 'Computerisation of Land Records (CLR) Program' all village maps have been scanned and preserved at the Central Survey Office, Chennai. The Director of Survey and Settlement has, therefore, requested to issue orders for using e-Service for downloading the village maps by the public at a cost of Rs.200/- per 'A1' sheet by integrating online payment facility.

3) The Director of Survey and Settlement has further stated that the fees (at a cost of Rs.200/- per 'A1' sheet) towards the sale of village maps may be credited in the head of Account " DPC 0029-00-800-AA-1499".

4) The Government, after careful examination, have decided to accept the proposal of the Director of Survey and Settlement and order for using e-Service for downloading the village maps by the public at a cost of Rs.200/- (Rupees Two hundred only) per 'A1' sheet by integrating online payment facility.

5) The fee collected above should be remitted in to Government account in the following head of account:
