ORDER

In the Government Order first read above, the penalty rates for impounding the cattle per day was lastly revised during the year 1995 as tabulated below:-

2. In the letter third read above, the Additional Chief Secretary/Commissioner of Revenue Administration has stated that the District Collector, Sivaganga has reported that due to efflux of time, the rate prescribed in the Government Order first read above is not sufficient to cater the needs of the maintenance of the cattle from the date of impound till their release, the cost of fodder, grass and other materials, provision of water and other items required for the cattle's livelihood has also increased. These expenditure cannot be met out from this fine amount which is already in vogue. Therefore, he has requested to issue necessary orders to enhance the penalty amount as suggested below for better implementation of Cattle Tress passers Act, 1871.

3. In the meantime the Additional Chief Secretary, Animal Husbandry, Dairying, Fisheries and Fishermen Welfare Department has stated that the Commissioner of Animal Husbandry and Veterinary Services has reported that

- Penalty i.e. a fine is charged from the owner for the safekeeping and feeding of the cattle in the pound.
- As the stray livestock are maintained in a pound, it is the responsibility of the pound keeper to cater the needs of the maintenance of the animals such as grass, fodder, provision of water and other materials.
- The cost of the penalty suggested by the Commissionerate of Additional Chief Secretary/ Commissioner of Revenue Administration to meet out the maintenance expenditure and the suggested penalty rate by the Commissionerate of Animal Husbandry and Veterinary Services is as follows: -

4. The Additional Chief Secretary, Animal Husbandry, Dairying, Fisheries and Fishermen Welfare Department has further stated that the above suggested rate has been decided on the basis of the current market rate of fodder and other maintenance source which is briefed as follows:-

The Government after careful examination on the proposal of the Additional Chief Secretary/Commissioner of Revenue Administration and as per the suggestion of the Additional Chief Secretary, Animal Husbandry, Dairying, Fisheries and Fishermen Welfare Department hereby order to revise penalty rates for impounding the cattle for the well maintenance of the livestock in a pound as tabulated below:-
