ORDER:

The Hon'ble Chief Minister has, in a Press Release, dated 28.10.2014, announced the release of a sum of Rs.60.00 crore towards repair for the damages caused to roads and tanks due to incessant rain and floods during the North East Monsoon -2014.

2. The State Relief Commissioner and Additional Chief Secretary/ Commissioner of Revenue Administration, in his report dated 29.10.2014, has stated that the Chief Engineer, Highways Department has informed that a sum of Rs.139.32 crore is required for temporary restoration of damaged roads stretching to a length of 4766 KM and sought for a sum of Rs.30.00 crore in the first phase for temporary restoration of 787.10 Km.

3. The Principal Secretary, Rural Development and Panchayat Raj Department has required a sum of Rs.309.36 crore for temporary and permanent restoration of Panchayat and Panchayat Union assets.

4. The Principal Secretary, Public Works Department in his report, dated 28.10.2014, has also requested a sum of Rs.12.84 crore for restoration of damages to various tanks, canal bunds, river bunds and other assets.

5. The Principal Secretary, Municipal Administration and Water Supply Department has also sought for a sum of Rs.10.00 crore for restoration of damages caused to the Municipality and Town Panchayat infrastructure viz., roads, water supply etc.,

6. Considering the prevailing flood situation and based on the request of the Heads of Departments, the State Relief Commissioner and Additional Chief Secretary/Commissioner of Revenue Administration has recommended to sanction a sum of Rs.60.00 crore under State Disaster Response Fund (SDRF), towards repair for the damages caused to roads and tanks due to incessant rain and floods during North East Monsoon -2014 to the implementing agencies by apportioning it in the following manner:

Highways Department	-	Rs.30.00 crore
Public Works	-	Rs.10.00 crore
Rural Development	-	Rs.10.00 crore
Municipal Administration	-	Rs.10.00 crore

Total	-	Rs.60.00 crore

7. The Government have examined the above proposal in detail and agreed to the recommendation of the State Relief Commissioner and Additional Chief Secretary/Commissioner of Revenue Administration and accord sanction for a sum of Rs.60.00 crore (Rupees Sixty crore only) under the State Disaster Response Fund(SDRF) towards repair for the damages caused to roads and tanks due to incessant rain and floods during North East Monsoon-2014 to the implementing agencies as detailed below:-

Highways Department	-	Rs.30.00 crore
Public Works	-	Rs.10.00 crore
Rural Development	-	Rs.10.00 crore
Municipal Administration	-	Rs.10.00 crore

8. The amount sanctioned in para 7 above shall be debited to the following head of account :

"2245 Relief on Account of Natural Calamities - 80 General - 800 Other Expenditure -I Non.Plan - AA Assistance for undertaking immediate relief works in connection with Flood/Fire/Drought - 09 Grants-in-Aid - 09 Others "

9. Necessary additional funds will be provided in RE/FMA 2014-2015 to meet the expenditure sanctioned in para 7 above. Pending provision of such funds in RE/FMA 2014-2015, the State Relief Commissioner and Additional Chief Secretary/Commissioner of Revenue Administration is authorized to draw and disburse the amount to the concerned Heads of Departments based on the recommendation of the Secretaries concerned. This should be brought to the notice of Legislative by specific inclusion in the Supplementary Estimates 2014-15. The State Relief Commissioner and Additional Chief Secretary/ Commissioner of

Revenue Administration is directed to include the expenditure sanctioned above, while sending the Budget proposal for RE/FMA 2014-2015 and also to send necessary Explanatory Notes for including the above expenditure in the supplementary Estimates 2014-15 to Finance (BG.I/Revenue) Department with out fail.

10. This order issues with the concurrence of Finance Department vide its U.O.No.60250/Finance(Revenue)/2014, dated 30.10.2014 and ASL No.1449 (One thousand four hundred and fourty nine).
