In the G.O. first read above, orders were issued for enhancing the monetary limits delegated to Revenue Officials in the grant of lease of Government Poramboke lands are as follows:-

4.	Commissioner of Land Administration	upto Rs.2,00,000/- (Rupees Two lakhs only)
5.	Government	above Rs.2,00,000/- (above Rupees Two lakhs)

2. In the letter 2nd read above, the Principal Secretary and Commissioner of Land Administration has recommended the enhancement of monetary powers delegated to various Revenue Officials in grant of lease, as follows:-

**Monetary limit:**

Sl. No	Designation of Officer	Recommended Monetary Limit
1.	Tahsildar	Nil
2.	Revenue Divisional Officer	upto Rs.1,00,000/- (Rupees One lakh only)
3.	District Revenue Officer	upto Rs.2,00,000/- (Rupees Two lakhs only)
4.	District Collector	upto Rs.5,00,000/- (Rupees Five lakhs only)
5.	Commissioner of Land Administration	upto Rs.10,00,000/- (Rupees Ten lakhs only)
6.	Government	above Rs.10,00,000/- (above Rupees Ten lakhs)

3. The Government, after careful examination, have decided to enhance the Monetary Powers delegated to various Revenue Officials in grant of lease of Government lands as follows:-

**Monetary Limit:**

2.	Revenue Divisional Officer	upto Rs.50,000/- (Rupees Fifty thousand only)
3.	District Revenue Officer	upto Rs.1,00,000/- (Rupees one lakh only)

4.	District Collector	upto Rs.4,00,000/- (Rupees Four lakhs only)
5.	Commissioner of Land Administration	upto Rs.5,00,000/- (Rupees Five lakhs only)
6.	Government	above Rs.5,00,000/- (above Rupees Five lakhs)
