ORDER:

In the Government Order first read above, orders were issued to increase the age of superannuation of Government servants/teachers from 59 years to 60 years. In the Government Order second read above necessary amendments to the Tamil Nadu Fundamental Rules were issued to that effect.

2. The Tamil Nadu Survey Officer's Union (central) in their representation third read above, have represented the Government to increase the age limit prescribed for the Assistant Director of Survey from 57 years to 59 years.

3. The Director of Survey and Settlement has also sent amendment proposal to rule 4 of the Tamil Nadu Survey and Land Records Service to increase the prescribed age limit from 57 years to 59 years for the post of Assistant Director of Survey.

4. The Government after careful examination hereby issue amendment to Rule 4 of the Tamil Nadu Survey and Land Records Service to increase the age limit

prescribed for the post of Assistant Director of Survey from 57 years to 59 years for appointment by recruitment by transfer consequent to the orders issued to increase the age of superannuation of Government Servants to 60 years.

5. The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Survey and Land Records Service Rules.

The amendment hereby made shall be deemed to have come into force on the 25th February 2021.

AMENDMENT

In the said Special Rules, in rule 4 in the Table, in column (4) against the entries "I" in column (1) and the Corresponding entries in columns (2) and (3) thereof, for the expression "fifty seven years of age", the expression "fifty nine years of age" shall be substituted.
