## ORDER:

The Government have enhanced the quota for deputing Assistant Section Officers / Assistants for Revenue Inspector training, by considering the facts that the number Districts and Taluks have been increased rapidly, which also increased the number of Firkas in the District. During the year 1980, the State had 1097 Revenue Firkas, of which nearly 5% quota (i.e.) 48 Revenue Firkas had been fixed for the deputation of Assistant Section Officers / Assistants of Erstwhile Board of Revenue and other city offices for the Revenue Inspectors' training in the Government order first read above and five increased for the Secretariat Assistant Section Officers only in the Government order second read above and again increased to 53 in the Government order third read above.

2. In the letter fourth read above, the Commissioner of Land Administration in his earlier proposal has recommended to enhance quota for his office since promotional avenues of staff in his office is affected and also to enhance Secretariat quota by 2 from 25 to 27. In the letter sixth read above, the President of Tamil Nadu Secretariat Association has also

requested to raise Secretariat Quota from the existing 25 to 50, for Revenue Inspectors' training.

3. In the letter seventh read above, the Additional Chief Secretary/ Commissioner of Revenue Administration has stated that Prohibition and Excise Department and Tamil Nadu State Disaster Management Agency Department's Association have requested to enhance Revenue Inspector training quota for their Assistants as such increase was given past 40 years ago, cadre strength of the Department is on rise and 50 eligible Assistants in the department are waiting for their chance for Firka Revenue Inspector training. The above request of the association has been examined in detail for revising the prescribed quota for deputing Assistants for Revenue Inspector's training in respect of Assistants working in Commissionerate of Revenue Administration and Disaster Management (Segment-II). He has also stated that Revenue Inspectors' training is mandatory for next level of promotion to all the Assistants working in this Commissionerate. Revenue Inspector Training is not mandatory for the next level of promotion to the Assistant Section Officers/Assistants who are all working in the Secretariat and other City Offices. At present, there are 38 Districts in the state having 1195 Revenue Firkas. 98 New Revenue Firkas have been newly created. During the last 40 years, the Revenue Administration Department has evolved into Revenue Administration and Disaster Management Department and the cadre strength of Assistants/ Superintendents, is on the rise, therefore there is a necessity for enhancement of quota of allocation of candidates for Revenue Inspectors' training, as may qualified Assistants are waiting for their turn for Revenue Inspector training. After evolvement of this Department as Revenue Administration and Disaster Management Department, approximately 15 Assistant and 6 Superintendent posts have been newly created; therefore an increase in Revenue Inspectors training quota is also necessary. He has, therefore, recommended the Government to allot the additional seats for the deputation for Survey and Settlement and Revenue Inspectors' training, in the following manner:-

- 4. After careful consideration of the request of the Additional Chief Secretary / Commissioner of Revenue Administration/Commissioner of Land Administration, the Government hereby decided to increase the Survey and Revenue Inspectors' Training from existing 53 to 70 persons as the Districts have been increased from 35 to 38 and firkas are increased from 1097 to 1195 in the following Manner:-
- I. (a) From 25 to 27 for Assistant Section Officers in Secretariat (Segment-I) (one unit 24 and Finance unit 3)
- (b) From 15 to 17 for O/o. Commissioner of Revenue Administration which includes Tamil Nadu State Disaster Management Agency / P&F (In segment-II)
- (c) From 7 to 20 for the O/o. the CLA / CLR / ULC /ULT / DOSS ( In segment-III)
- (d) No change in the other City Office (i.e,) 6 Office (In segment-IV)
- (II) On account of the above, to enhance the existing Quota for RI training from 53 to 70 persons from the City List for the deputation of Survey and Settlement and Revenue Inspector are in the following manner:

(III) Subject to the following conditions:-

(i) Candidates shall be deputed to 10% Revenue Firkas of a District, except the Nilgiris District.

- There shall not be more than 70 candidates deputed to Revenue Inspectors' (ii) training at any point of time under any circumstances.
- The un-availed posts / allocation in a Segment shall be diverted to other (iii) Segments by Commissioner of Revenue Administration and shall be filled up with eligible persons based on their seniority, from other segments in a particular year.
- 5. The Additional Chief Secretary/Commissioner of Revenue Administration is requested to follow the above order accordingly.
