#### **ORDER:**

In the Government Order first read above, Government accorded sanction for the following posts in 12 coastal districts and 19 non coastal districts and Thiruvarur upto 31.07.2018

#### subject to the following conditions:-

(i) Break in service has to be given in every year before the completion of one year service to the persons appointed / to be appointed in the above project on temporary/ contract/consolidated pay outsourcing basis.

- (ii) The claims for permanent absorption from the candidates after appointment in the above project should not be considered.
- (iii) Assurance in writing has to be obtained from the candidates during the time of appointment that they should not claim for permanent absorption.
- 2. In the Government Order fourth read above, Government accorded sanction for the further continuance of the above posts, for the District Disaster Management Authority in all the 32 Districts 01.08.2020 to 31.07.2021.
- 3. In the letter second read above, the Principal Secretary and Commissioner of Revenue Administration has stated as follows:
  - i. The Junior Assistants, Typist-cum- Computer Operators and Office Assistants have been appointed on temporary basis on consolidated pay in the Disaster Management Sections of all the Districts with the consolidated pay of Rs.10,000/- per month for Junior Assistants and Typist-cum-Computer Operator and Rs.7,000/- per month for Office Assistants from the year 2015. Now, representations seeking enhancement of pay have been received from the Junior Assistant, Typist-cum-Computer Operators and Office Assistants who are working on temporary basis on consolidated pay in the Disaster Management Section in the Districts.
  - ii. The District Collectors have requested orders of the Government for fixing the minimum wages for the above categories for the year 2019-2020. On scrutinizing the minimum wages fixed by the District Collectors, it is observed that in almost all the Districts temporary staff in the category of Typist-cum-Computer Operator, Junior Assistants and Office Assistants are getting pay lower than the minimum wages fixed by the District Collectors. Hence, the salary of the above categories may be fixed after giving a hike of 30% as per the norms prescribed in the 7th pay commission by the Government as detailed below:

The Principal Secretary and Commissioner of Revenue Administration has therefore requested orders of the Government to revise the consolidated pay of the staff working in District Disaster Management Authority as per G.O.(Ms) No. 303, Finance (Pay Cell) Department, dated 11.10.2017 (7<sup>th</sup> Pay Commission) by giving a hike of 30% as detailed below:-
