ORDER:

The Honourable Minister for Revenue and Disaster Management has made the following announcement in the Legislative Assembly on 31.08.2021:-

“அ’ பதிவேடு, சிட்டா, புலப்படம் ஆகியவை நில ஆவணங்களை சாகுபடி, நில பயன்பாடு விவரங்களை உள்ளடக்கிய இணைய வழி அடங்கல் ஆவணங்களுடன் ஒருங்கிணைப்பதன் மூலமாக நில உரிமைதாரர்களுக்கு ஒருங்கிணைந்த நில ஆவணம் வழங்குதல்”.

2. In the letter read above, the Director of Survey and Settlement has stated that 'A' Register and Chitta of Rural Villages have been computerized and brought online using web-based TamilNilam. Extract of 'A' Register, Chitta / Patta are made available in 'Anytime Anywhere e-services'. Similarly, Field Measurement Sketch (FMS) have been digitized and brought online separately under the above e-services.

3. The Director of Survey and Settlement has further stated that adangal data has been computerized and brought online through online workflow in e-adangal software by Revenue Administration department. However, there is no Integrated Land Document available comprising all the above Land Records viz., A-register, Chitta, FMS and e-Adangal. An integrated document is required by farmers for getting crop loans and subsidies and for various other services. Sensing this essential requirement, it has been proposed to provide a 'Integrated Land Document' to the farmers and general public.

4. The Director of Survey and Settlement has also stated that in order to implement the above announcement, he has enclosed a tentative format for Integrated Land Record (ILR) herewith. Since 'A' Register, Chitta and FMS are already online, the NIC can be requested the Government to take immediate action to integrate them. Data pertaining to Online 'A' Register and Chitta are currently shared with Revenue Administration department for being used in e-Adangal. Necessary action will be taken to obtain the updated cultivation particulars from e-adangal dynamically shared with TamilNilam.

5. The Director of Survey and Settlement has also stated that after the e-adangal data is shared, 'Integrated Land Record' comprising data from 'A' Register, Chitta, FMB & e-adangal can be dynamically generated and published in e-services of 'Anytime / Anywhere' for being downloaded by the public.

6. The Director of Survey and Settlement has requested to approve the specimen format of the 'Integrated Land Record' and to issue permission to coordinate with NIC to develop the same in TamilNilam.

7. To implement the announcement made by Hon'ble Minister for Revenue and Disaster Management, the Government hereby approve the specimen format of the 'Integrated Land Record' (ILR) detailed in the Annexure. The Director of Survey and Settlement is requested to coordinate with NIC to develop the same in TamilNilam.

8. The Director of Survey and Settlement is directed to pursue necessary further action with reference to the orders issued in para 7 above.
