ORDER:

In the Budget Speech on 13.08.2021, the Hon'ble Minister for Finance and Human Resources Management had among others announced

"Over 2.05 lakh hectares of the Government of Tamil Nadu's land was encroached, as recorded in the Government's own "Tamil Nilam" database in 2017. To improve management of the public land, an advanced Government Land Management System will be created which will contain full details of all Government Lands. This will prevent State's assets from being used inefficiently, misused, or even diverted".

2. The Commissioner of Land Administration and Director of Survey and Settlement were requested to take necessary action for creation of "Government Land Management System".

3. In this regard it is submitted that Government lands are classified into various categories and they are managed by the concerned departments based on the usage assigned for such Government lands.

4. The constraints in the current scheme of things are as detailed below.

- (i) Not properly managed
- (ii) No proper master register
- (iii) No accountability
- (iv) Lots of encroachments
- (v) Improper/Inefficient usage

5. In order to ensure proper management of Government Land, a common Land Management System is proposed to be created. It will be a subset of Tamil Nilam and will be maintained separately and linked to reflect real time status.

6. Further additional data set will be created to monitor the usage of these lands in Tamil Nilam, beyond those available including encroachment/ current usage/ prohibitions/ conditions/lease status/user status/ future plan etc. It will be an official database (not public).

7. The Government have examined the matter in detail and hereby order the constitution of the Committee comprising of the following members:

8. The Committee will finalise the modalities and exact details of required system which will be implemented by National Informatics Centre, Chennai. The Commissioner of Land Administration/Director of Survey and Settlement will co-ordinate with National Informatics Centre and related departments such as Tourism, Culture and Religious Endowments/Water Resources Department/Rural Development & Panchayat Raj/Municipal Administration & Water Supply/Finance/Animal Husbandry, Dairying, Fisheries and Fishermen Welfare Department /Environment, Climate Change & Forest / Adi-Dravidar and Tribal Welfare Departments to make the system foolproof.

9. The Committee will define the exact specifications of this Land Management System and its Specific linkages with various departments. The Committee will also indicate the requirements of funding and Supervision System to create and manage this system.
