# **ORDER:**

In the Government order first read above, the Government have issued orders according sanction for obtaining loan under Indira Awaas Yojana from HUDCO for Rs.746.10 Crore (Rupees Seven Hundred and Forty Six Crores and Ten lakhs only) with necessary guarantee for loan liability and Budgetary Support every year for repayment of principal and floating rate of interest through Tamil Nadu Rural Housing and Infrastructure Development Corporation.

- 2. In the Government order second read above, the Government have sanctioned a sum of Rs.5,72,53,479/- (Rupees five crores seventy two lakhs fifty three thousand four hundred and seventy nine only) towards payment of interest to Housing and Urban Development Corporation for the first quarter of 2014-15.
- 3. In the reference third read above, the Commissioner of Rural Development and Panchayat Raj (i/c) has stated that sufficient provision is available under:

"2216 Housing -03-Rural Housing – 789 Special Component Plan for Scheduled Castes – JB Scheme for construction of Concrete Houses for Scheduled Castes – 09 Grants in Aid -02 Grants for Creation of Capital Assets"

"2216 Housing -03-Rural Housing - 800 Other Expenditure— JA Scheme for construction of Houses for other Backward Classes - 09 Grants in Aid -02 Grants for Creation of Capital Assets"

- 5. The Commissioner of Rural Development and Panchayat Raj (i/c) has therefore requested the Government to reappropriate the above requirement of funds and to issue necessary orders to authorize her to draw and disburse the amount to Tamil Nadu Rural Housing and Infrastructure Development Corporation/ Housing and Urban Development Corporation towards repayment.
- 6. The Government, after careful examination of the proposal of the Commissioner of Rural Development and Panchayat Raj (i/c), sanction a sum of Rs.44,14,63,999/- towards repayment of Principal and payment of interest to Housing and Urban Development Corporation (HUDCO) through Tamil Nadu Rural Housing and Infrastructure Development Corporation towards loan obtained for the implementation of Indira Awaas Yojana Scheme (State Share) for the year 2014-2015.
