ORDER:-

Hon'ble Minister (Municipal Administration, Rural Development, Law, Courts and Prisons) while moving Demand No.42 on 01.08.2014 has announced the following Announcement No.9 on the floor of the Assembly,

“சுய தொழில் பயிற்சி அளிப்பதில் மிக்க அனுபவம் பெற்ற பயிற்சி நிறுவனங்களின் மூலம் தனியாகவோ அல்லது குழுவாக இணைந்தோ சுயதொழில் மேற்கொள்ள ஆர்வமுள்ள மகளிருக்கு மூலப்பொருட்கள் கொள்முதல், இயந்திரங்கள் நிறுவுதல், மதிப்புக்கூட்டுதல், விலை நிர்ணயித்தல் மற்றும் தரச்சான்று பெறுதல் போன்ற அம்சங்களை உள்ளடக்கி தொழில் முனைவோர் பயிற்சி வழங்கப்படுகிறது. மாண்புமிகு தமிழ்நாடு முதலமைச்சர் இதயதெய்வம் புரட்சித் தலைவி அம்மா அவர்களின் ஆணையின்படி, 4000 நகர்ப்புற மற்றும் கிராமப்புற மகளிர் சுய உதவிக்குழு பெண்களுக்கு தலா ரூ.5,000 செலவில் சுய தொழில் செய்யவும் மற்றும் நிறுவனங்களில் பணிபுரியவும் தொழில் முனைவோர் பயிற்சிகள் 2014-15-ஆம் ஆண்டில் ரூ.2.00 கோடி செலவில் வழங்கப்படும்”.

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in her D.O. Letter second read above has stated that Tamil Nadu Government has been spearheading economic empowerment of women by bringing the poorest of poor and unreached families into the SHG network, establishing and strengthening the self managed institutions of the poor and by enhancing their capacity. Corporation for Development of Women coordinates various initiatives taken by the State government towards the social and economic well being of women. In attempting to deal with challenges in the livelihood promotion of the poor, the importance of Entrepreneurship Development Training cannot be under estimated. It improves productivity, increase adaptability to deal with change and crisis and facilitate the diversification of livelihoods to manage risks. It is imperative that opportunities are given to poor women for capacity building and skill development to promote their own enterprise and also address the challenges in creation of sustainable livelihoods. To address this Challenge, Government of Tamil Nadu has been imparting Entrepreneurship Development Training to Self Help Group members who are in the age group of above 35 years and who are interested in taking up economic activities. This skill training is imparted through reputed training institutions and also covering subject such as procurement of raw material and machineries, value addition, costing and certification. This training has helped many women to take up income generating activities thereby improving their socio-economic status. It has also helped women to manage and market their production more effectively, to take advantage of new opportunities and manage new production technologies. Many women have diversified their productive activities by branching out into new enterprises.

3. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has added that in view of the announcement made by the Hon'ble Minister (Municipal Administration, Rural Development, Law, Courts and Prisons) it is proposed to give Entrepreneurship Development Training to 4000 Self Help Group members from both urban and rural areas, in the age group of above 35 years and who are interested in taking up economic activities, at an average cost of Rs.5,000/-. The actual cost of the training will vary depending on the trade selected and the duration of the training. Selection of trades and institutions, etc will be decided by the District level Committee headed by the District Collector based on needs and demands from the location for enterprise development and self-employment with credit support. An amount of Rs.2,00,00,000/- (Rupees Two crores only) is proposed for providing Entrepreneurship Development Training programme for Urban & Rural Self Help Group women in the financial year 2014–2015.

Cost Estimation: 4,000 SHG women X Rs.5000 (average cost) = Rs.2,00,00,000/-

4. The Managing Director, Tamil Nadu Corporation for Development of Women Limited has therefore requested the Government to issue necessary orders sanctioning a sum of Rs.2.00 crores (Rupees Two crores only) to organise Entrepreneurship Development Training to 4000 Self Help Group women members from both urban and rural areas during the year 2014-15.

5. The Government after careful examination of the proposal of Managing Director, Tamil Nadu Corporation for Development of Women Limited above, accept it and accord sanction for a sum of Rs.2.00 Crores (Rupees two crores only) for organizing Entrepreneurship Development Training to 4000 Self Help Group women members from both urban and rural areas during the year 2014-15.
