ORDER:-

Hon'ble Minister (Municipal Administration, Rural Development, Law, Courts and Prisons) while moving Demand No.42 on 01.08.2014 has announced the following Announcement No.7 on the floor of the Assembly,

“2014-15-ஆம் ஆண்டில், இது வரை சுய உதவிக் குழுவில் உறுப்பினராக சேராத ஆதரவற்றோர், ஏழைகள், நலிவுற்றோர், மாற்றுத் திறனாளிகள் மற்றும் பழங்குடியினரைக் கொண்டு 10,000 சுய உதவிக் குழுக்கள் அமைக்கப்படும். இதற்காக நடப்பு ஆண்டில் ரூ.35.00 இலட்சம் ஒதுக்கீடு செய்யப்படும்”.

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in her D.O. letter read above has stated that Hon'ble Minister for Rural Development has announced in the floor of the Assembly on 1st August, 2014 that 10,000 New Self Help Groups (SHGs) will be formed in the State focusing on destitute, poor, vulnerable, differently abled and scheduled tribe who are not member of any SHG and all support will be extended to them. An amount of Rs.35 lakhs will be spent for this purpose during 2014-15. Tamil Nadu Corporation for Development of Women Limited is implementing the Tamil Nadu State Rural Livelihood Mission (TNSRLM) from the year 2012-13 with the aim of providing sustainable livelihoods to the economically weaker sections of society in the State. Tamil Nadu State Rural Livelihoods Mission adopts Participatory Identification of Poor (PIP) process to identify the poor and vulnerable.

3. She has further stated that Tamil Nadu State Rural Livelihoods Mission is implemented by aggregating the identified poor into Community based Organizations of identified Self Help Group, Panchayat Level Federation & Common Livelihood Group. Accordingly the poor identified through PIP will be formed into Self Help Groups. In the year 2014-15, 10,000 new Self Help Groups will be formed in 60 blocks of 15 Phase-I Tamil Nadu State Rural Livelihoods Mission districts by bringing the left out poor, destitute, vulnerable, differently abled and scheduled tribe into the fold of Self Help Group network identified through the Participatory Identification of Poor (PIP) process.

4. She has further stated that Self Help Group Formation cost @ Rs.350/- per Self Help Group to be paid to the Village Poverty Reduction Committee for formation of a new Self Help Group. The cost of formation of 10,000 new groups works out to Rs.35.00 lakhs (Rs.350 per group x 10,000 groups). She has therefore requested the Government to issue necessary orders sanctioning a sum of Rs.35.00 lakhs towards the cost of formation of 10,000 new Self Help Groups for the year 2014-15 to be paid to the Village Poverty Reduction Committees pending provision of funds in the Revised Estimate for the year 2014-15 under the following Head of Account.

“2235. Social Security and Welfare-02. Social Welfare 103 – Women’s Welfare – Schemes in the Twelfth Five Year Plan-II. State Plan - LO Assistance for formation of Self Help Groups - 09. Grants-in-aid - 03. Grants for specific schemes. (DPC 2235-02 103 LO 0933)”.

5. The Government after careful examination of the proposal of Managing Director, Tamil Nadu Corporation for Development of Women Limited direct the Managing Director, Tamil Nadu Corporation for Development of Women Limited for the formation of 10,000 Self Help Groups at a cost of Rs.35.00 lakhs from the funds of National Rural Livelihoods Mission and also direct that no state fund shall be utilized.
