ORDER:

In the Government order first read above, the Government have approved the guidelines for provision of farm ponds under Mahatma Gandhi National Rural Employment Guarantee Scheme on lands belonging to Scheduled Caste/Scheduled Tribes, Small and Marginal farmers and other categories of farmers in Thanjavur, Tiruvarur, Nagapattinam, Tiruchirappalli, Karur, Ariyalur, Pudukkottai, Cuddalore and other districts, if any, notified by the Government of India.

- 2. Subsequently, in pursuance of announcement made by the Hon'ble Chief Minister on the floor of the Legislative Assembly under rule 110 on 19.04.2013, orders have been issued for the provision of 50,000 farm ponds in 23 Non-delta districts to mitigate the drought situation vide Government letter second read above.
- 3. The Director of Rural Development and Panchayat Raj, in the letter third read above, has stated that detailed instructions along with district-wise target have been issued to the District Collectors / Chairman, District Rural Development Agencies. Out of this target, 20591 farm pond works have been taken up, 15108 farm pond works completed, 5483 works are under progress leaving out a balance of 29409 works.
- 4. The Director of Rural Development and Panchayat Raj has further stated that due to certain practical difficulties in the identification of beneficiaries wherein some of the selected beneficiaries had been found to be unwilling to part with their land for the provision of Farm Ponds, there has been a set-back in taking-up balance 29409 Farm pond works. These 29409 farm pond works have been redistributed among the 23 Non-Delta Districts and 30 Non-Delta Blocks of 5 Delta Districts. He has sent the

revised target for Non-Delta Districts and the proposed target for Non- Delta Blocks of Delta Districts.

- 5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue amendment to the orders issued in Government Letter No.10446/CGS.1/ 2013-2, Rural Development and Panchayat Raj Department, dated 20.5.2013 to undertake the 50,000 Farm ponds in both 23 Non-Delta Districts and 30 Non-Delta Blocks of 8 Delta Districts instead of 23 Non-delta Districts only.
- 6. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, issue amendment to the orders issued in Government Letter No.10446/CGS.1/ 2013-2, Rural Development and Panchayat Raj Department, dated 20.5.2013 and accord permission to undertake the 50,000 Farm ponds in both 23 Non-Delta Districts and 30 Non-Delta Blocks of 8 Delta Districts instead of 23 Non-Delta Districts only as annexed to this order.
