

ABSTRACT

Mahatma Gandhi National Rural Employment Guarantee Scheme – Payment of third quarter of Grants –in-aid as central assistance amounting to Rs.490.2048 Crore (Rupees Four hundred ninety Crore twenty lakh and forty eight thousand only) for the year 2014-15 released by the Government of India under MGNREGS – Sanction of a sum of Rs.490.2048 Crore accorded – Orders issued.

ORDER:

In the Government order first read above, the Government have accorded sanction for a sum of Rs.734.85 Crore as central assistance as first and second part of 1st Tranche for the implementation of the Mahatma Gandhi National Rural Employment Guarantee Scheme for the financial year 2014-15.

2. In the Government order second read above, the Government have accorded sanction for a sum of Rs.993.4117 Crore as central assistance as second quarter for the implementation of the Mahatma Gandhi National Rural Employment Guarantee Scheme for the financial year 2014-15.

3. In the Government order third read above, the Government have accorded sanction for a sum of Rs.563.3368 Crore as central assistance as third quarter for the implementation of the Mahatma Gandhi National Rural Employment Guarantee Scheme for the financial year 2014-15.

4. The Ministry of Rural Development, Government of India, in the letter fourth read above, have conveyed the sanction of the payment of third quarter of Central

assistance Grants-in-aid amounting to Rs.490.2048 Crore to the State Government of Tamil Nadu for the implementation of the MGNREGS for the financial year 2014-15 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

5. The Director of Rural Development and Panchayat Raj, in the letter fifth read above, has stated that the above amount sanctioned in G.O (Ms) No.67, Rural Development and Panchayat Raj (CGS.1) Department, Dated 05.06.2014, G.O (Ms) No.104, Rural Development and Panchayat Raj (CGS.1) Department, Dated 22.08.2014 and G.O (Ms) No.146, Rural Development and Panchayat Raj (CGS.1) Department, Dated 13.11.2014 respectively. However, proposals were sent to Government of India seeking additional funds to the tune of **Rs.510.93 crore** – a sum of Rs.105.00 Crore towards pending liability for wages and a sum of Rs.405.63 Crore towards pending liability for the material component.

6. The Director of Rural Development and Panchayat Raj has further stated that the Government of India in Letter No.J-12034/1/2014/MGNREGA-VI, SI.No.109, Dated 17.12.2014 has issued orders releasing funds to the tune of Rs.490.2048 Crore (Rupees four hundred ninety crore twenty lakh and forty eight thousand only) as grantsin-aid as 3rd quarter of Central Assistance to Government of Tamil Nadu under Mahatma Gandhi National Rural Employment Guarantee Scheme for the financial year 2014-15 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period. The Director of Rural Development and Panchayat Raj has also stated that there is insufficient balance of funds in the State Employment Guarantee Fund account for release to the nodal banks toward disbursement of wages.

7. The Director Rural Development and Panchayat Raj has therefore requested the orders of the Government on the following taking into consideration of the urgent need of funds and the above liability requirement in respect of wages to be paid to the workers:

 to sanction a sum of Rs. 490.2048 Crore as balance of 3rd quarter release of Central assistance as detailed below under the following head of account:
