ORDER:

As such, he has requested to direct the State Nodal Officers to initiate the campaign in the Saansad Adharsh Gram Yojana(SAGY) Gram Panchayats to witness the significant outcomes in bringing effective behavioural change and fulfilling the objectives and send an Action Taken Report(ATR) in this regard.

The Government examined the matter and hereby appoint Dr.Pinky Jowel,I.A.S., Special Secretary to Government, Rural Development and Panchayat Raj Department, Secretariat, Chennai-9, as State Nodal Officer with immediate effect to coordinate COVID-19 related works for Rural Development and Panchayat Raj Department.


