ORDER:

In the Government order first read above, the Government directed the Chairman and Managing Director, Tamil Nadu Cements Corporation Limited (TANCEM) to procure and place purchase orders for 8.40 lakh MTs of OPC 43 Grade cement for 2013-14 from the private cement manufacturers at the rate of Rs.220/- per bag for the implementation of the Schemes in Rural Development and Panchayat Raj Department.

2. In the Government order second read above, the Government issued the following orders:

- (i) Tamil Nadu Cements Corporation Limited (TANCEM) is permitted to supply 4.00 Lakh Metric Tons of cement to Rural Development and Panchayat Raj Department from its own production for the year 2014-15
- (ii) Tamil Nadu Cements Corporation Limited (TANCEM) being the nodal agency for procurement of cement is also permitted to float suitable tenders for the procurement of remaining 7.27 Lakh Metric Tons of cement from private manufacturers following the due procedure and to supply to Rural Development and Panchayat Raj Department for the year 2014-15

3. In the G.O third read above, the Government accorded permission to extend the rate delivery period for procurement of 8.40 lakh MTs of 43 Grade OPC for the year 2013-14 at the rate of Rs.220/- per bag from the Private Cement Manufacturers for another two months from the date of expiry of tender falls on 6.11.2014 i.e., from 7.11.2014 to 6.1.2015.

5. The Managing Director, Tamil Nadu Cements Corporation Limited has furnished following details of supply of cement as on 23.12.2014:

6. The Managing Director, Tamil Nadu Cements Corporation Limited has stated that finalization of new tender for the year 2014-15 is under process and may take some more time. One of the tenderers also had not supplied the offered quantity. After taking into account the defaulted supply quantity and to sort out the crisis situation, Board of Tamil Nadu Cements Corporation Limited in its 262nd meeting held on 11.12.2014 resolved to invoke the additional 25% quantity as per tender conditions in accordance with the provisions of Tamil Nadu Transparency in Tender Act 1998 and Rules 2000. Based on the above, additional quantity 2.10 lakh MTs have been generated. Further, Board accorded approval to reallocate the defaulted quantity to the willing suppliers at the existing rate. Since the extension period granted by Government expires on 6.1.2015, the additional generated quantity could not be supplied within the stipulated extension period.

7. The Managing Director, Tamil Nadu Cements Corporation Limited has therefore requested the Government to consider the further extension of the delivery period from 7.1.2015 to 31.3.2015.

8. The Government, after careful examination of the proposal of Managing Director, Tamil Nadu Cements Corporation Limited, accord permission to extend the rate delivery period for procurement of 8.40 lakh MTs of 43 Grade OPC for the year 2013-14 at the rate of Rs.220/- per bag from the Private Cement Manufacturers upto 31.3.2015 i.e., from 7.1.2015 to 31.3.2015.
