ORDER:

In the letter read above, the Director of Rural Development and Panchayat Raj has stated that the Government of India approved the Annual Implementation Plan 2014-15 and indicated the initial allocation of Rs. 205.11 Crore for Tamil Nadu under Nirmal Bharat Abhiyan (NBA). Now, Nirmal Bharat Abhiyan has been restructured as Swachh Bharat Mission (G) with effect from 2nd October 2014. For the year 2014-15, the Government of India have released the Central Share through State Government.

2. The Director of Rural Development and Panchayat Raj has also stated that the Government of India have released Rs. 4,22,44,000/- (Rupees four crore twenty two lakh and forty four thousands only) the part of first installment of Grant-in-aid under Swachh Bharat Mission (Gramin) for the year 2014-15 as detailed below:

The Director of Rural Development and Panchayat Raj has further stated that the Government in Finance Department have provided Rs. 430.84 Crore in B.E. / FSE for 2014-15 under Nirmal Bharat Abhiyan including Central Share and State Share in the following head of account. This amount of Rs. 430.84 Crore includes Central share of Rs. 205.11 Crore and State share of Rs. 135.15 Crore for the year 2014-15 and balance amount of Rs. 90.58 Crore for the State share arrear for the year 2013-14.

As per Government of India guidelines, the States shall release the Central grants received along with the matching State share to the District implementing agencies / agencies (DSBM(G)) within 15 days of receipt of Central Grants.

- 4. The Director of Rural Development and Panchayat Raj has therefore requested the Government to authorize the Director of Rural Development and Panchayat Raj to draw the above amount of Central Share of Rs.4,22,44,000/- (Rupees four crore twenty two lakh and forty four thousands only) from the Government head of account and to disburse the same to the Districts along with corresponding State Matching share.
- 5. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, release Rs.4,22,44,000/- (Rupees four crore twenty two lakh and forty four thousands only) towards Central share under Swachh Bharat Mission (Gramin) for the year 2014-15 and authorize the Director of Rural Development and Panchayat Raj to draw the amount from the Government head of account and to disburse the same to the Districts along with corresponding State Matching share.
- 6. The amount released in para 5 above shall be debited under the following head of account:
