ORDER:

In the Government order first read above, orders have been issued approving the guidelines for the construction of Individual Household Latrines (IHHL) independently under Mahatma Gandhi National Rural Employment Guarantee Scheme at a unit cost of Rs.10,000/-.

2. The Director of Rural Development and Panchayat Raj, in the letter second read above, has stated that in order to give impetus to the programme and to achieve a clean India by 2019 the Swachh Bharat Mission (SBM) has been launched. As a part of this programme, superseding earlier guidelines/letters issued on the subject from the Ministry of Rural Development vide Letter No.J-11017/41/2011-MGNREGA (Part) dated 11.09.2012, 13.06.2013, 19.08.2013 and 06.01.2014 and revised guidelines for construction of Individual Household Latrines (IHHL) under Mahatma Gandhi National Rural Employment Guarantee Act have been issued vide Joint Secretary (MGNREGA), Ministry of Rural Development, Government of India Letter No.J-11017/41/2011-MGNREGA (Part) dated 25.11.2014.

3. The Director of Rural Development and Panchayat Raj has also stated that in the revised guidelines, it has been indicated that the unit cost of Individual Household Latrines independently taken up under Mahatma Gandhi National Rural Employment Guarantee Scheme has been enhanced to Rs.12,000/- in respect of the sanctions issued after 02.10.2014. He has therefore requested the Government

to issue necessary amendment to the G.O.(Ms).No.32 Rural Development and Panchayat Raj (CGS.1) Department dated 03.03.2014 to increase the unit cost from Rs.10,000/- to Rs.12,000/- for the construction of Individual Household Latrines (IHHL) independently taken up under Mahatma Gandhi National Rural Employment Guarantee Scheme .

4. The Government, after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, issue amendment to the orders issued in G.O.(Ms).No.32 Rural Development and Panchayat Raj (CGS.1) Department dated 03.03.2014 and direct that the unit cost of Rs.10,000/- be increased to Rs.12,000/- for the construction of Individual Household Latrines (IHHL) independently taken up under Mahatma Gandhi National Rural Employment Guarantee Scheme .
