ORDER:

In the Government order first read above, the Government have approved the draft memorandum and bye-laws of the Tamil Nadu Sanitation and Waste Management Society and authorized the Director of Rural Development and Panchayat Raj to register the new society with the name “Tamil Nadu Sanitation and Waste Management Society (TANSWAMS)”. In the Government order, first read above the objectives have been prescribed for the society and Governing Body and Executive Committee have also been constituted. In the Government order first read above, the Director of Rural Development and Panchayat Raj has been permitted to take action for winding-up of the defunct society already registered in 2003 as per the provisions of Tamil Nadu Societies Registration Act, 1975.

2. The Director of Rural Development and Panchayat Raj, in the letter second read above has stated that the names and designations quoted in the Government order first read above and in the Memorandum of Association and the Register of Members have been mentioned therein verified and it was found that certain names and designations quoted therein have since changed.

3. The Director of Rural Development and Panchayat Raj has therefore proposed the certain amendment to the G.O.(Ms).No. 66, Rural Development and Panchayat Raj (CGS-1) Department, dated 04.06.2014.

4. The Government, after careful examination of the proposal of Director of Rural Development and Panchayat Raj, issue the following amendment:

- 1) The Names that have been mentioned in Table in Column (2) of Para 3 against Sl.No. 1 – 23 and Sl.No. 1 – 7 of Draft Memorandum of Association given in the Annexure of the Government order first read above shall be omitted.

- 2) The Names that have been mentioned in Form No. VI – Register of Members as in Sl.No. 1 – 28 in the Annexure to the Government order first read above shall be omitted.
- 3) In Para 6 of the Government order Para 3 of the Memorandum of Association and Form No. VI – Register of Members as in Sl.No. 4 and Sl.No. 18 in the Annexure to the said Government order first read above shall be substituted as follows:
