ORDER :

In the Government Order first read above, orders were issued for creating three posts viz., State Quality Coordinator, Accounts Officer and IT Nodal Officer, exclusively for State Rural Roads Development Agency (SRRDA) for execution of rural road connectivity works under Pradhan Mantri Gram Sadak Yojana (PMGSY) / Bharat Nirman Scheme which is functioning under the control of Rural Development and Panchayat Raj Department for a period of one year or till the necessity ceases thereof, whichever is earlier.

2. In the Government Order 2nd read above orders were issued for continuance of the above three posts for a period of one year from 01.09.2009 to 31.08.2010.

3. In the Government Order 3rd read above orders were issued for continuance of the above three posts for a period of one year from 1.9.2010 to 31.8.2011.

4. In the Government Order 4th read above orders were issued for continuance of the above three posts for a period of one year between 01.09.2011 and 31.08.2012.

5. In the Government Order 5th read above orders were issued for continuation of the above three posts for a period of two years from 01.09.2012 to 31.08.2014 and the remuneration payable to State Quality Co-ordinator (S.Q.C) and Accounts Officer (PMGSY) was also enhanced.

6. In the Government Order 6th read above orders were issued for continuance of the above there posts for a period of one year for 01.09.2014 to 31.08.2015.

7. In the Government Order 7th read above orders were issued for continuance of the above there posts for a period of one year for 01.09.2015 to 31.08.2016.

8. The Director of Rural Development and Panchayat Raj vide his letter 8th cited supra has stated that there is an absolute necessity for continuance of the three posts viz., State Quality Co-ordinator, Accounts officer and IT Nodal Officer for effective implementation of Pradhan Mantri Gram Sadak Yojana/Bharat Nirman programme in Tamil Nadu State and has therefore requested continuance of the above three posts for another three years.

9. The Government after careful examination of the proposal of the Director of Rural Development and Panchayat Raj, Chennai and issues the following orders:-

- i. The three posts i.e. State Quality Coordinator, Accounts Officer and IT Nodal Officer of State Rural Roads Development Agency be continued for a period of one year from 01.09.2016 to 31.08.2017.
- ii. There shall be no change in the monthly emoluments for all the three posts i.e.,
