### **ORDER:**

In the Government order first read above, the Government have accorded Administrative sanction for the road works under Pradhan Mantri Gram Sadak Yojana Phase IX (2014-15) for Rs.359.88 Crore and maintenance cost for Rs.24.37 Crore. In the Government Order second read above, a sum of Rs.98.5289 Crore has been released towards Rs.58.2598 Crore for Phase VIII works and Rs.40.2691 Crore for Phase IX works as PMGSY Central grant to Tamil Nadu Rural Housing and Infrastructure Development Corporation account for 2016-17.

2. In the letter fourth read above, the Director of Rural Development and Panchayat Raj has stated that the Director(RC), Ministry of Rural Development, Government of India has released Rs.55.7661 Crore towards Programme Fund under Phase IX works to State Government as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for 2016-17.

3. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue order for the release of Rs.55.7661 Crore (Rupees Fifty Five Crore Seventy Six Lakhs Sixty One Thousand only) released by the Government of India, Ministry of Rural Development.

4. The Government after careful examination have decided to accept the request of the Director of Rural Development and Panchayat Raj, Chennai. Accordingly, the Government direct that release a sum of Rs.55.7661 Crore (Rupees Fifty Five Crore Seventy Six Lakhs Sixty One Thousand only) released by the Government of India to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) Phase IX for the year 2016-17.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

“4515-00-Capital outlay on Other Rural Development Programmes,-  
103 - Rural Development – Schemes in the Twelfth Five Year Plan-  
II-State Plan - JG-Roads/ Bridge works under PMGSY – Bharat  
Nirman - 16 - Major Works. (DPC 4515 – 00-103-JG-1608)”

6. Necessary additional provision of Rs.55,76,61,000/- will be provided in FMA 2016-17 The Director of Rural Development and Panchayat Raj is authorized to draw and transfer the amount sanctioned in para 4 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
