ORDER:

In the Government order first read above, the Government accorded Administrative Sanction for the road works under Pradhan Mantri Gram Sadak Yojana Phase VIII (2012-13) for Rs.1130.10 Crore which was revised to Rs.1128.74 Crore after dropping 3 road works and maintenance cost for Rs.61.91 Crore. Based on this Government order the Ministry of Rural Development has released Rs.343.48 Crore in 2013-14, which was directly credited to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) account as per the rule in vogue at that time.

2. In the Government order second read above, a sum of Rs.100 crore has been released as grants-in-aid to TNRHIDC towards part payment of 1st installment under Phase VIII of PMGSY for the financial year 2014-15 as per the restructured programme. In the Government order third read above, a sum of Rs.121.89 Crore has been released as grants-in-aid to TNRHIDC towards balance of 1st instalment and part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2014-15. In the Government order fourth read above, a sum of Rs.15.00 Crore has been released as grants-in-aid to TNRHIDC towards part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2014-15. In the Government Order fifth read above, a sum of Rs.53.00 crore has been released as grants-in-aid to TNRHIDC towards part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2015-16. Government Order sixth read above a sum of Rs.1.5775 Crore has been released as grants-in-aid to Tamil Nadu Rural Housing and Infrastructure Development Corporation towards part payment of 2nd instalment under Phase VIII of Pradhan Mantri Gram Sadak Yojana for the financial year 2015-16. In the Government order seventh read above, a sum of Rs.34.86 Crore has been released as central assistance under Phase VIII of Pradhan Mantri Gram Sadak Yojana towards part payment of 2nd instalment for the financial year 2015-16. In the Government Order eighth read above, a sum of Rs.27.13 Crore has been released as Pradhan Mantri Gram Sadak Yojana grants to Tamil Nadu Rural Housing and Infrastructure Development Corporation as central assistance for PMGSY Phase VIII. In the Government Order ninth read above, a sum of Rs.37.86 crore has been released as Pradhan Mantri Gram Sadak Yojana grants to Tamil Nadu Rural Housing and Infrastructure Development Corporation as central assistance for PMGSY Phase VIII. A sum of Rs.45.9575 Crore has been released as PMGSY grant to Tamil Nadu Rural Housing and Infrastructure Development Corporation for PMGSY Phase VIII vide the Government Order tenth read above. In the Government Order eleventh read above, a sum of Rs.4.615 Crore has been released as PMGSY grant to Tamil Nadu Rural Housing and Infrastructure Development Corporation for PMGSY Phase VIII. In the letter twelfth read above, the Director (RC), Ministry of Rural

Development, Government of India had stated that the Government of India, Ministry of Rural Development has released Rs.39.09 Crore to the State Government of Tamil Nadu under Vote on Account (April-May, 2016) as central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the financial year 2016-17 and also mentioned that the amount would be adjusted against a specific phase/ Batch during the regular release of 1st instalment under PMGSY for the financial year 2016-17. The above sum was already credited to State Government Account. In the Government Order thirteenth read above, a sum of Rs.39.09 Crore has been released as PMGSY grant to Tamil Nadu Rural Housing and Infrastructure Development Corporation for PMGSY Phase VIII.

- 3. The Government have accorded Administrative sanction for the road works taken up under Pradhan Mantri Gram Sadak Yojana Phase IX(2014-15) for Rs.359.88 Crore and maintenance cost for Rs.24.37 Crore vide the Government Order fifteenth read above.
- 4. In the letter sixteenth read above, the Director of Rural Development and Panchayat Raj has stated that the Director (RC), Ministry of Rural Development, Government of India has released Rs.98.5289 Crore (Rupees Ninety Eight Crore Fifty Two Lakhs Eighty Nine Thousand only) to State Government of Tamil Nadu as central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for 2016-17 towards Phase VIII(Rs.58.2598 Cr) and Phase IX(Rs.40.2691 Cr) works.
- 5. The Director of Rural Development and Panchayat Raj has therefore requested the Government to issue order for the release of Rs.98.5289 Crore (Rupees Ninety Eight Crore Fifty Two Lakhs Eighty Nine Thousand only) released by the Government of India, Ministry of Rural Development and to transfer the fund to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) within 3 days from the date of receipt of funds, failing which further releases will be stopped and the State Government is liable to pay interest @ 12% for the period of delay.
- 6. The Government after careful examination have decided to accept the request of the Director of Rural Development and Panchayat Raj, Chennai. Accordingly, the Government direct that release a sum of Rs.98,52,89,000 (Rupees Ninety Eight Crore Fifty Two Lakhs Eighty Nine Thousand only) released by the Government of India to the State Government of Tamil Nadu as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) Phase VIII and IX for the year 2016-17.
- 7. The expenditure sanctioned in para 6 above shall be debited under the following head of account:-

"4515-00-Capital outlay on other Rural Development Programmes - 103 - Rural Development - Schemes in the Twelfth Five Year Plan-II-State Plan - JG-Roads/ Bridge works under PMGSY - Bharat Nirman - 16 - Major Works (DPC 4515 - 00-103-JG-1608)"

- 8. The Director of Rural Development and Panchayat Raj is authorized to draw and transfer the amount sanctioned in para 6 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
