Mission Antyodaya - Constitution of State Level Steering Committee under Chief Secretary to Government for implementation of 'Mission Antyodaya' - Orders - Issued.

ORDER:

In the letters read above, the Director of Rural Development and Panchayat Raj has stated that the Government of India has introduced Mission Antyodaya as a Central–State partnership programme to bring one crore household out of poverty and to make 50,000 Village Panchayats in the country poverty free by 2nd October 2019. This will be achieved by addressing all the dimensions of poverty through convergence of various Government schemes, sharing of infrastructure and resources and multi-pronged strategies to target households based on their specific deprivation. In Tamil Nadu, 2509 Village Panchayats have been identified across the State by District Collectors to implement 'Mission Antyodaya' with the aim to make them poverty free by 2nd October 2019.

- 2. The Director of Rural Development and Panchayat Raj has also stated that Mission Antyodaya is completely a state-led initiative where the intention is to demonstrate the power of convergence in transforming rural areas. The State Government has to create a detailed strategy for making a real difference to the lives of the poor and deprived households in the selected Mission Antyodaya Village Panchayats based on the inputs from the frame work for implementation evolved by the Ministry of Rural Development, Government of India.
- 3. The Director of Rural Development and Panchayat Raj has further stated that the Government of India, Ministry of Rural Development has suggested among others, that establishing co-ordination structures at various levels in the State for guiding the implementation of 'Mission Antyodaya' is absolutely necessary for better monitoring of interventions and outcomes in these 'Mission Antyodaya' Village Panchayats. Framework for implementation of 'Mission Antyodaya' recommends constitution of a State Level Co-ordination Committee under Hon'ble Chief Minister and State Level Steering Committee under Chief Secretary to Government.

4. The Director of Rural Development and Panchayat Raj has stated that there is no mention about the composition of the State Level Co-ordination Committee in the frame work designed by Ministry of Rural Development, Government of India. In the absence of guidelines and frame work design, the Government may decide the composition of the State Level Co-ordination Committee as it deems fit and necessary. Further, he has requested the Government to issue orders for constituting the State Level Steering Committee headed by Chief Secretary to monitor the programme and plan for its successful implementation as suggested by Ministry of Rural Development, Government of India with the following Members:-

- 5. The Director of Rural Development and Panchayat Raj has informed in his proposal the illustrative list of functions of State Level Steering Committee as following:
 - i. To prepare master Government Orders/ Resolutions detailing different processes and procedures.
 - ii. To ensure inter-departmental co-ordination at all levels.
 - iii. To issue instructions on convergence of schemes and resources including detailing of human resources and technical support at all levels.
 - iv. To take decisions as needed for mid-course corrections, trouble-shooting, etc.
 - v. To respond to issues from the field and come out with circulars/clarifications.
 - vi. Identify bottlenecks and the technical and administrative support required and issue necessary instructions/Government Orders from time-to-time.
 - vii. Co-ordinate with the committee at the national level as required.
 - viii. To monitor and steer the entire process.
 - ix. The Steering Committee should decide the resource envelope which will be available to Village Panchayats/clusters, keeping in view the objective of 'Mission Antyodaya' and ensure that the State Government communicates the same to each Village Panchayats in form of a Government Order (by developing appropriate Management Information System(MIS)). It should mandatorily include the following:
 - a. Fourteenth Finance Commission (FFC) Grant
 - b. State Finance Commission(SFC) Grants
 - Own Source Revenue(OSR) to be projected based on actual of the last three years
 - d. Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) as per approved Labour Budget

- e. Pradhan Mantri Awas Yojana(Gramin) (PMAY-G)
- f. Rashtriya Krishi Vikas Yojana (RKVY)
- g. Pradhan Mantri Krishi Sinchayee Yojana (PMKSY)/ Watershed Management Programme (WMP)
- h. Horticulture Technology Mission
- i. Pradhan Mantri Fasal Bima Yojana(PMFBY)
- j. National Social Assistance Programme (NSAP)
- k. Deen Dayal Upadhayaya Grameen Kaushalya Yojana(DDUGKY)
- I. National Rural Livelihood Mission (NRLM)
- m. Other Centrally Sponsored Schemes(CSS) and State Schemes entrusted to Village Panchayats.
- n. Schemes for which Village Panchayat takes the decision even when the fund is not transferred.
- o. Voluntary contributions (cash, kind and labour)
- p. Corporate Social Responsibility (CSR) funds, if assured and available to Village Panchayats.
- 6. The Director of Rural Development and Panchayat Raj has requested the Government to issue orders for constituting the State Level Co-ordination Committee headed by Hon'ble Chief Minister as deemed fit and necessary and State Level Steering Committee under Chief Secretary with functions as mentioned above to carry forward the Mission successfully.
- 7. The Government after careful examination of the proposal of Director of Rural Development and Panchayat Raj have decided to accept it and issue orders for constitution of "State Level Steering Committee" headed by Chief Secretary to Government with the composition of the following Members and function as mentioned in para 5 above, to carry forward the Mission successfully:-
