ORDER:

Ministry of Rural Development, Government of India has sanctioned Rs.1,81,98,500/- as 1st installment of Administrative Expenses Fund under Pradhan Mantri Gram Sadak Yojana for the year 2017-18, which has been released in the Government Order first read above.

2. In the letter second read above, the Director of Rural Development and Panchayat Raj has stated that no proposal for State matching Share was sent to Government, as there was no specific mention about State Share in the Ministry of Rural Development's letter. Ministry of Rural Development has allotted Rs.600 Crore, out of which Rs.12.75 Crore towards Administrative Expenses Fund for the year 2018-19. When proposal for Central release of Administrative Expenses Fund for the year 2018-19 was sent to Ministry of Rural Development, the Ministry wanted the details of State matching Share for the year 2017-18 and requested to credit the State matching Share in State Rural Road Development Agency account.

3. The Director of Rural Development and Panchayat Raj has therefore requested to release a sum of Rs.1,21,32,333/- (Rs.1,81,98,500x40/60) as corresponding State matching Share to the extent of Central release of Rs.1,81,98,500/- as Administrative Expenses Fund under PMGSY for the year 2017-18, so as to obtain funds for the year 2018-19. He has also requested the Government to authorize him to draw and transfer the sanctioned amount to Tamil Nadu Rural Housing and Infrastructure Development Corporation Administrative Expenses Fund Account.

4. The Government, after careful examination, have decided to accept the proposal of Director of Rural Development and Panchayat Raj and accord sanction a sum of Rs.1,21,32,333/- (Rupees One crore twenty one lakh thirty two thousand three hundred and thirty three only) (Rs.1,81,98,500x40/60) as corresponding State matching Share to the extent of Central release of Rs.1,81,98,500/- as Administrative Expenses Fund under Pradhan Mantri Gram Sadak Yojana for the year 2017-18.

5. The expenditure sanctioned in para 4 above shall be debited under the following head of account:-

"4515-00-Capital outlay on Other Rural Development Programmes -
103 - Rural Development – Schemes shared between State and Centre
UA - Roads/Bridge works under PMGSY – Bharat Nirman - 16 - Major
Works.

6. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned at para 4 above to Tamil Nadu Rural Housing and Infrastructure Development Corporation account.
