ORDER:

In the Government Order first read above, orders along with detailed Guidelines were issued for the implementation of the “Chief Minister’s Solar Powered Green House Scheme” and administrative sanction was also accorded for a sum of Rs.1260 crore and it was also ordered to release initially a sum of Rs.252 crore for the year 2015-16.

2. The Director of Rural Development and Panchayat Raj in his letter 2nd read above, has stated that the total allocation in BE/RE/FMA 2015-16 under Chief Minister’s Solar Powered Green House Scheme is Rs. 1260.00 crores. So far Rs. 1065.00 crores have been drawn and a sum of Rs.117,35,20,205/- have been released as final installment to Districts towards construction for the year 2014-15 and Rs.855,41,81,906/- released to Districts for the year 2015-16 and the balance amount released to TEDA for installation of solar lights. Further, he has stated that based on the proceedings dated 9.3.2016 for drawal of Rs.120.00 crore an amount of Rs.100,47,49,480 was drawn and was released to the

Districts towards construction and the balance amount released to TEDA for installation of home lights for the year 2013-14 and 2014-2015. The Director of Rural Development and Panchayat Raj has further stated that during the first year of inception of the scheme in 2011-12 only 50% of the total allocation (i.e.) Rs.540 crore alone was provided by the Government as against the required amount of Rs.1080.00 crore. Moreover during the 2nd year (2012-13) out of Rs.1080 crore, only Rs.1042.70 crore was received from Government. The short release during the year 2011-12 and 2012-13 was met out from the Budget Estimate of the subsequent years. An amount of Rs 117,35,20,205/- was already utilized from BE 2015-16 towards the release of final installment of Chief Minister's Solar Powered Green House Scheme 2014-15 to the Districts for civil construction. For the year 2015-16, so far Rs.855,41,81,906/- alone has been released to Districts towards construction and still Rs.224,58,18,094/- is required for completion of these houses.

3. The Director of Rural Development and Panchayat Raj has further requested the Government for providing balance amount of Rs.224,58,18,094/- from respective head of accounts under Chief Minister's Solar Powered Green House Scheme (CMSPGHS) so as to settle the bills to beneficiaries who construct the houses amidst much hardships and thereby complete the scheme target successfully.

4. The Government have examined the proposal of the Director of Rural Development and Panchayat Raj in detail and have decided to accord sanction and release of Rs. 112,29,09,047/- (Rupees One Hundred and twelve crore twenty nine lakhs nine thousand and forty seven only) under Chief Minister's Solar Powered Green House Scheme.

5. The amount sanctioned in para 4 above shall be debited under the following Head of Account:-
