ORDER:

In exercise of the powers conferred under section 27 of the National Rural Employment Guarantee Act, the Central Government directed the State Government to set up the office of the Ombudsman for redressal of grievances in a time bound manner. Accordingly, necessary orders have been issued in G.O. first read above, establishing the Office of the Ombudsman for redressal of grievances under Mahatma Gandhi National Rural Employment Guarantee Scheme and prescribing procedure for selection, qualification, tenure, territorial jurisdiction etc., regarding the appointment of Ombudsman. In the G.O. second read above, the Selection Committee for selection and appointment of Ombudsman was reconstituted.

2. In the letter third read above, the Director of Rural Development and Panchayat Raj was requested to send revised proposal to reconstitute the Selection Committee. In his letter fourth read above, the Director of Rural Development and Panchayat Raj has requested the Government to reconstitute the Selection Committee with the following members for selection and appointment of the ombudsmen for District or cluster of Districts:-

- a) Additional Chief Secretary of the State : Chairperson
Government nominated for the purpose
- b) Principal Secretary/Secretary of the State : Member-Convener
Nodal Department
- c) Representative of Union Ministry of Rural : Member
Development
- d) Eminent Civil Society person nominated : Member
by Union Ministry of Rural Development

3. The Government after careful examination, have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and issue orders for reconstitution of the Selection Committee for selection and appointment of Ombudsman as follows:-

- a) Additional Chief Secretary to Government, : Chairperson
Planning, Development and Special
Initiatives Department
- b) Principal Secretary to Government, Rural : Member-
Development and Panchayat Raj Convener
Department
- c) Representative of Union Ministry of Rural : Member
Development
- d) Eminent Civil Society person nominated by : Member
