Mahatma Gandhi National Rural Employment Guarantee Scheme – 3rd installment of 1st Tranche of Central Assistance for Material component released by Government of India – Sanction a sum of Rs.797,80,30,667/- (Central and State Share) for the year 2019-20 – Accorded – Orders – Issued.

ORDER:

In the Government Order first read above, the Government have sanctioned a sum of Rs.15,01,00,000/- as 1st installment of 1st Tranche of Central and State share for Material Component for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme. In the Government Order second read above, the Government have sanctioned a sum of Rs.104,31,81,333/- as 2nd installment of 1st Tranche of Central and State share for Material Component for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

2. In the letter third read above, the Director of Rural Development and Panchayat Raj has stated that now the Government of India in the Letter No.J-12034/2/2019-RE-VI, SI.No.59, dt.05.08.2019 have sanctioned a sum of Rs.598,35,23,000/- (Rupees Five Hundred and Ninety Eight Crore Thirty Five Lakh Twenty Three Thousand Only) towards Material component as 3rd installment of 1st Tranche of Central Assistance for implementation of the Mahatma Gandhi National Rural Employment Guarantee Act for the financial year 2019-20 on condition that the State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days of receipt of funds failing which the State Government would be liable to pay a penal interest of 12% for the period of delay beyond the specified period.

3. The Director of Rural Development and Panchayat Raj has further stated that the expenditure per person-day generation of wage employment shall have wage and material costs in the proportion of 60:40. The cost of wages is 100% borne by Government of India and as per Rule 22(1)(b) and (2)(b) of the NREGA Act 2005, the expenditure on material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25. Hence, considering the release amount Rs.598,35,23,000/- (Rupees Five Hundred and Ninety Eight Crore Thirty Five Lakh Twenty Three Thousand Only) by Government of India as 75% share towards Material component the State has to

bear the balance 25% of the cost of the material component which amount to Rs.199,45,07,667/- (Rupees One Hundred and Ninety Nine Crore Forty Five Lakh Seven Thousand Six Hundred and Sixty Seven only).

4. The Director of Rural Development and Panchayat Raj has therefore requested orders of the Government to sanction 3rd installment of 1st tranche of Central Assistance along with the proportionate State Share towards Material component for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme and requested to permit him to draw and transfer the amount to the State Employment Guarantee Fund of Tamil Nadu.

5. The Government after careful examination have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accord sanction of a sum of Rs.598,35,23,000/- (Rupees Five Hundred and Ninety Eight Crore Thirty Five Lakh Twenty Three Thousand Only) towards Material component as 3rd installment of 1st tranche of Central Assistance along with the proportionate State Share Rs.199,45,07,667/- (Rupees One Hundred and Ninety Nine Crore Forty Five Lakh Seven Thousand Six Hundred and Sixty Seven only) totally a sum of Rs.797,80,30,667/- (Seven Hundred and Ninety Seven Crore Eighty Lakh Thirty Thousand Six Hundred and Sixty Seven only) for the year 2019-20 under Mahatma Gandhi National Rural Employment Guarantee Scheme.

6. The expenditure sanctioned in para 5 above shall be debited under the following heads of account:
