ORDER :

In the Government Order first read above, administrative sanction was accorded for Rs.50.00 Crore for the implementation of Self Sufficiency Scheme during the year 2018-19 and released Rs.25.00 Crore and issued detailed guidelines for its implementation.

2. In the letter second read above the Director of Rural Development and Panchayat Raj has stated that the District Collector, Nagapattinam has submitted a proposal along with Detailed Project Report seeking permission for the construction of Mini Fishing Harbour in Nambiyar Nagar, Nagapattinam District at an estimated cost of Rs.34.30 Crore under Self Sufficiency Scheme for the year 2018-19 and has also requested to sanction Rs.22.86 Crore as Government Grant. The Detailed Project Report submitted by the District Collector, Nagapattinam has been prepared by Executive Engineer, Fishing Harbour Project Division, Nagapattinam, through an Engineering Consultant and it is proposed to execute the work through Fisheries Department.

3. He has also stated that the District Collector in the justification report has indicated that, establishing the Mini Fishing Harbour Project at Nambiyar Nagar, Nagapattinam District will facilitate holding 66 mechanised boats and 252 fishing boats and will also help more than 5,000 fishermen for whom fishing is the main source of livelihood. It has also been indicated that 7 out of 11 Blocks in the District are situated near seashore and for most of the people in these areas, fishing is the main source of

livelihood, hence establishing a Mini Fishing Harbour in Nambiyar Nagar will be very helpful to the fishing community and would fulfill their long pending demand. He has also mentioned that the local community is willing to make the required minimum Public Contribution and in anticipation of approval they have already mobilised an initial amount of Rs.5.70 Crore and kept it in a Bank account. The perusal of the Project Report reveals that Detailed Project Report (DPR) has been reviewed and approved by Department of Ocean Engineering, IIT, Madras.

4. He has stated that the aforesaid work does not fall either under suggested list or negative list of works under the Self Sufficiency Scheme guidelines 2018-19 and has indicated that the Government has already accorded permission for taking up of such similar works benefiting the coastal community with higher project cost, viz., construction of Groynes at Kadiyapattinam Village, Kanniyakumari district, which was executed by the Fisheries Department at an estimated cost of Rs.15.00 Crore under Self Sufficiency Scheme, 2015-16.

5. He has stated that the construction of Mini Fishing Harbour is unique to Self Sufficiency Scheme in respect of its stated importance, utility, benefits entailing higher project cost. This Project will also be financially viable during 2018-19, if necessary permission is given to utilise from the balance amount of Government Grant of Rs.25.00 Crore (Rs.50.00 Crore - Rs.25.00 Crore) as already sanctioned in the Government Order first read above.

6. The Director of Rural Development and Panchayat Raj has therefore requested the Government to accord permission for construction of Mini Fishing Harbour at Nambiyar Nagar, Nagapattinam District at an estimated cost of Rs.34.30 Crore for the year 2018-2019 under Self Sufficiency Scheme with the condition that 1/3rd of the Project cost (i.e) Rs.11.43 Crore should be collected as Public Contribution besides getting necessary statutory environmental clearances from the competent authorities before issuing Administrative Sanction.

7. The Government have carefully examined the proposal of the Director of Rural Development and Panchayat Raj in detail and decided to accord permission for the Construction of Mini Fishing Harbour at Nambiyar Nagar, Nagapattinam District at an estimated cost of Rs.34.30 Crore (Rupees Thirty Four Crore and Thirty Lakh Only) under Self Sufficiency Scheme for the year 2018-19 with 1/3rd project cost of Rs.11.43 Crore as a public contribution considering the fact that establishing Mini Fishing Harbour at Nambiyar Nagar, Nagapattinam District will improve the livelihood of fishing community in the coastal region of Nagapattinam District. Accordingly, the Government sanction Rs.22.87 Crore (Rupees Twenty Two Crore and Eighty Seven Lakh only) being 2/3rd of project cost.
