- 2. Kanniyakumari, Theni and Krishnagiri.

The Government after careful examination have decided to accept the proposal of the Director of Rural Development and Panchayat Raj and accordingly release the amount of Rs.1,05,00,000/- (Rupees One crore five lakh only) sanctioned by the Government of India as Grants-in-Aid under National Rurban Mission for preparation of Integrated Cluster Action Plan to the Phase-III Districts viz. Kanniyakumari, Theni and Krishnagiri.

- 5. Necessary additional funds of Rs.1,05,00,000/- will be provided in RE/FMA 2017-18. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2017-2018. Pending provision of such funds, the Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 3 above. He is also directed to include this item of expenditure while sending the budget proposal for RE/FMA 2017-2018 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2017-2018 to Government in Finance (RD&PR/BG-I) Department at the appropriate time without fail.
